

A REAL FRIEND

A little more than twenty years ago the writer began teaching Plane Surveying at Willamette University. The principal instrument was an extremely old-fashioned transit in very poor repair. One summer Percy Brown of Silverton, a mechanical genius, borrowed it to do a little surveying on his father's farm. When the instrument came back in the fall it was in excellent condition, perfectly aligned, and had been fitted with a strong, stable tripod. Thanks to Percy Brown.

It must be about twelve years ago that Professor Tillman, our teacher in Physics, a Johns Hopkins man, took charge of the instruction in surveying. Under his direction the trustees appropriated money for the purchase of a K. and E. transit, and a K. and E. level. These instruments are still in use and in good condition. The ancient transit was sold to a carpenter for twenty-five dollars.

With the increasing demand for instruction in Engineering, the

writer once more in charge of the work in Surveying has wished for additional instruments to make an expansion that seemed absolutely necessary.

But just now Civil Engineering appliances are expensive, almost double in price since the great war began, and how were we to

purchase them?

Our extremity was a good friend's opportunity, a modest friend who does not wish his name printed in connection with any announcement of his gift. I am sure, however, that the angels have written him down on a white page. With this gift amounting to two hundred dollars we have added to our equipment a new hand level, stadia rod, pins, steel tape, flexible rod, plane table, and a very superior alidade, fitted with telescope and stadia hairs.

Now we are ready to offer good courses in leveling, transit work,

and plane table surveying.

Our timely friend is an alumnus of W. U. He is not forgetful of his alma mater, and his manner of remembering is worthy of imitation.

CHANGES IN THE FACULTY

Coach Mathews Back.

Coach R. L. Mathews, who had been doing engineering work on the U. S. Irrigation Project in the Yakima Valley since last June, returned in January to the University as a member of the faculty. He was enthusiastically received by both faculty and students and soon arranged an athletic schedule for the remainder of the year. The work in basketball was eminently satisfactory. A feature of the year was the Valley Tournament in basketball at which Willamette acted as host. Visiting teams were Salem, McMinnville, Forest Grove, Newberg, Corvallis, Junction City and Drain. Salem High earried off the honors and the cup.

Professor Egge Resigns

Great regret was felt among faculty and students when President Doney announced on March 25th the resignation of Professor A. E. Egge, head of the English department. Continued ill health which necessitated a double major operation caused the resignation. At this writing the operations have been performed and there are hopes that Professor Egge will recover. Many expressions and tokens of esteem from the faculty and student body were conveyed to him. Professor Egge holds the Ph. D. from Johns Hopkins and taught for nineteen years in Washington State College. He came to Willamette last autumn when Professor Darden accepted an appointment to the Officers' Training Camp at the Presidio. Professor Egge's refined and cultured personality and ability and his patience through great suffering won to him the entire personnel of the school.

Professor Darden Returns

When it was learned that Professor Egge had resigned from the English department, Lieut. W. A. Darden, who was Personnel Adjutant in the Infantry Officers' Training School at Camp Lee, Petersburg, Va., was secured to take his place. He is welcomed enthusiastically by all. Professor Darden was Personnel Adjutant at Willamette during the time of the S. A. T. C. here. He was Professor of English at the University during the year 1917-18.

AN HISTORIC PAGEANT

In commemoration of the seventy-fifth anniversary of the opening of Willamette University, an historic pageant will be given on the campus at commencement time. On the Sunday preceding or following commencement week, a praise and thanksgiving service will be held. More than two hundred persons will participate in the pageant, which will be given on an especially constructed stage. The pageant will consist of thirty scenes including the interludes or connecting parts, which will consist of orchestral music, chorus singing, tableaux, and a masque. It will be about three hours in length and will be given several times, on different days. It will be played by students of Willamette who will represent men and women who aided in founding and developing the University. Professor Della Crowder-Miller, of the department of Public Speaking, wrote and will direct the pageant.

UNIVERSITY NEWS

The Freshman Class this year is the largest in the history of the school. It numbered at the opening of the year 68 men and 66 women.

Miss Ruth Fields, A. B. '06, Music '08, left in October for Calcutta, India, where she now is teaching in a girls' high school of 400 students.

The Wallulah will be issued this year at commencement time instead of on May Day. Vera Wise is editor and Lyle Bartholomew is business manager. Send orders to Mr. Bartholomew. The book promises to be unique and beautiful.

The May Queen this year is Miss Margarette Wible, a senior in music. Gladys Nichols and Helen Rose are maids of honor and Lawrence Davis is manager of May Day festivities. Lyle Bartholomew, manager of the Greater Willamette Club, is assistant manager. New Courses of Study will be outlined in the annual catalog soon to appear. These are: Pre-Law, Pre-Engineering, Pre-Journalism, Pre-Chemical Engineering, Pre-Medicine, and Pre-Domestic Science. These courses will cover four years of work.

The Freshman Glee this year aroused the usual interest in the University and city. The Armory was packed. Beautiful decorations had been arranged and the classes made a very fine appearance. The singing was excellent and the audience only wished that everybody could win. The sophomores carried off the honors with their song entitled, "Willamette, Here's to You."

At the Mid-Year Meeting of the Board of Trustees, held in Portland February 7, plans were discussed for celebrating the seventy-fifth anniversary of the opening of Willamette University and a program for a greater Willamette was proposed. These plans embody among other things a banquet in Portland in the late spring. The committee in charge of this banquet are President Doney, Dr. W. W. Youngson of the Portland District, and Dr. Joshua Stansfield of First Church, Portland.

A New Building was erected upon the campus about the middle of the year. The occupation of Science Hall by the S. A. T. C. made this necessary to accommodate the Y. M. and Y. W. and two literary societies. The building is bungalow style and is 32 by 46 feet, one story. The Chrestophilian and Chrestomathean literary societies gave \$400 to this building with the understanding that they should occupy it after the S. A. T. C. should be disbanded. The balance of the money was raised among the Salem friends of the school and a few other towns. The total cost was about \$1200.

The University Library grows steadily. It now contains about 1900 volumes, and over 100 magazines and papers are received regularly. Certain amounts of money already have been set aside for an alcove in honor of Dr. John H. Coleman, who was president of the University during the period 1902-8. Last year the Hon. Henry Clews, a New York banker and friend of Dr. Coleman, added \$500 to this fund. We hope other friends of Dr. Coleman will contribute. Besides numerous works added by purchase, many books have been presented to the library during the year by the following: Senator Robert A. Booth, Rev. Robert E. Smith, Rev. C. D. Day, Pres. Carl G. Doney, Chas. M. Stewart, and Frank A. Francis, '15

The Washingtonians, composed of members of the faculty and students from the state of Washington, gave the usual banquet this year on Washington's birthday, having invited the trustees, faculty, and other students. The Ladies' Aid Society of the First Methodist Church served the dinner. Miss Fay Peringer, for the Washingtonians, introduced President Doney as toastmaster. Mr. A. A. Lee spoke for the trustees and Professors Matthews and Von Eschen for the faculty. Other speakers were: the seniors, Miss Lelia Johnson; the juniors, Francis Cramer; the sophomores, Lawrence Davies; and the freshmen, Ralph Barnes.

SOME FRIENDS WHO HAVE DIED

Since the last issue of this Quarterly Mr. P. W. Severson has passed away. Mr. Severson died in Portland, Oregon, at the age of eighty-five years. His death resulted from an attack of influenza. For many years Mr. Severson was a friend and loyal supporter of Willamette University, and all who knew him and those who knew only how the University was indebted to him, feel keenly the loss. His

picture and that of Mrs. Severson, who preceded him several years, hang in the chapel in Waller Hall, but his greatest monument is in the lives of the young men and women whom his princely gifts have helped through his support of Willamette. He will not be forgotten.

We record with profound sorrow the death of Mrs. P. J. Brix, who yielded to the dread disease, influenza, January 23, after a long struggle bravely endured. The sympathy of all the friends of Willamette goes out to Mr. Brix, a trustee of the institution, and to his family. Mrs. Brix was a true friend of all but especially of young women, in whose education she was greatly interested. But her good work will be continued through the years to come.

ALUMNI AND STUDENTS WHO HAVE DIED

The sympathy of all connected in any way with the University is extended to those families bereaved by the deaths recorded below. Willamette will not forget them, for they possessed her spirit.

Edith Frizzel-Reynolds, A. B. '95, passed away at Riverside, Cal., March 16, 1918. She was the wife of L. T. Reynolds, '94, of Salem.

Word comes of the death some time since of Elwina Schramm-Pfaff, A. B. '14, but particulars are wanting.

Ellen L. Farrington, B. M. '03, died at Stayton, Oregon, in July, 1918.

Bentley Lockhart, Ex'20, died in a motor accident in St. Johns, last October.

Evadne McCully, Arts '21, died of influenza December 27. Evadne was the daughter of Mr. and Mrs. F. F. McCully of Joesph, Oregon. She was a very promising student and lovable character and the entire faculty and student body mourn her loss.

Arnold E. Hall, a son of Dr. J. E. and Fannie Hall of Portland, and a graduate of Willamette of the class of 1916, died November 13, last, in Portland of double pneumonia following influenza, after an illness of less than a week.

"MY BOYS"

From the diary of PRESIDENT DONEY, written at Nevers, France, April 24, 1918

For months I have sought and keenly anticipated that which this day has brought me. A college president who is not thinking and dreaming and praying about his students who are in the war would be an anomalous creature. I knew where a large number of my boys were located and I was anxious, eager and in a hurry to reach them.

At seven o'clock this evening I spoke at a camp on the outskirts of Nevers and one of the students, having learned of the appointment, had secured leave and was there. Of course I saw him in the crowd and could not keep my eyes away from him; I think he was the handsomest man I ever looked upon, and he was but a foretaste of what was coming. He rode to the city with me, asking and answering questions. "Yes, your parents are well and send worlds of love; your father is just the same wonderful Professor Matthews." "Vic and Bill and Rodney and "Swede" and Jack and Joe—they are all here."

It was late and we were taken directly to the Y hut and hurried to the platform. It was a new introduction for a speaker in France: a ripping, splitting, roaring college yell. There were my boys—two rows of them in front—giving me welcome after the old Willamette fashion. And there never was a yell like that: a roar, a crash, a frenzy; it was a symphony, a paean, a jubilation; it was unique America at home in France.

No one can know what such a moment means to a college president. It might not mean much to the president of a populous university where intimate friendships are not often possible; but I knew every one of these boys, knew their ways and ambitions, knew much of their home life, their struggles, troubles and doubtings; they were a real part of myself. And here they are giving themselves freely to serve their country, setting aside cherished plans and facing an unknown which is filled with yet other sacrifices and utmost dangers. Why should I not care for them and honor them and be touched to tears when I find them in this far-away, strange land! True, brave, enduring boys! swearing fealty to an ideal and pledging all they have to make that ideal become a reality in the world.

No speaker ever had a better reason to do his best: sympathy, expectation and appreciation were bestowed to the full. And after the address came the personal greetings, deluges of questions and worlds of joy. We jabbered—it was not talking—and laughed and shook hands over again; oh, it was a real breaking lose, worth a dozen trips across the ocean to experience it, and—taps. Taps! when we had just commenced; to be endured, however, because I am to be here

for four blessed days, four blessed days.

Those wonderful boys! My boys, for they call me "Prexy."

WILLAMETTE'S WAR SERVICE ROLL

The University desires to have a complete record of the service of all her men. In order to give information to alumni and friends of the school and to assist in securing complete data, the following list is published at this time. This information has come to us in no systematic way and it is not presumed that it is entirely correct. We shall be glad to have our attention drawn to errors and shall be thankful to receive further information from men in the service and from their friends.

Those Who Have Made the Supreme Sacrifice.

Eric P. Bolt, Arts '15, was in the Army Y. M. C. A. work at Vancouver Barracks. He died November 10, 1918, of pneumonia, following a relapse

from influenza. His home address was Marshfield, Oregon.

Ivan Bellinger, Med. '13, offered himself for the Army Medical Reserves and received his call in December, 1917. He was a Lieutenant in Company 14, Medical Officers' Training Camp, at Fort Riley, when he died with bronchial pneumonia, January 17, 1918.

Edward Gittins, Jr., Ex, died May 24, 1918, at Portland, of pneumonia.

He was in the service at Camp Lewis.

Charles A. Guerne, Ex '09, was a member of the 8th Observation Battery, Officers' Training Corps, Camp Taylor. He died there of influenza October 18, 1918.

Harlan R. Hoffman, Arts '21, died November 6, 1918, at Salem, of pneumonia following influenza. Mr. Hoffman was a member of the Willamette University S. A. T. C.

lamette University S. A. T. C. Ray Mark, Law '13, was accidentally gassed in New York and died there

in March, 1918.

George L. Rardin, Arts' 20, enlisted in Co. M. 3rd Oregon, and died at Vancouver Barracks Hospital, August 31, 1918. His home address was Centralia, Washington.

Faculty Members and Trustees in the Service.

President Carl G. Doney was invited by the Y. M. C. A. to go upon an observation and lecture tour through France. He left in February and returned in July, having spent the time in Paris and in various camps and in the front line trenches. He met many Willamette men, and since returning has been engaged for many lectures upon his experiences while with the army.

Professor William A. Darden was among the men appointed for training at the Presidio. He was commissioned a Lieutenant and returned to Willamette as Personnel Adjutant. When the S. A. T. C. at Willamette was disbanded, Lieutenant Darden was transferred to the Infantry Officers' School at Camp Lee, Petersburg, Va., where he was Personnel Adjutant. He has returned to Willamette as Professor of English.

Professor A. A. Hall of the College of Law is a ranking Captain in the

Adjutant General's Office in Portland, Oregon.

Dr. John O. Hall of the Department of Social Science, is in government service in the Department of Statistics, Washington, D. C., having gone there

in October, 1918.

Paul B. Wallace of the Board of Trustees enlisted as a Sergeant in Co. M. 3rd Oregon, and later was commissioned a Lieutenant and transferred to Co. L. 162nd Infantry, Sunset Division, France. Lieutenant Wallace was wounded in the Argonne drive.
