

nual gift plan. The Willamette fund was started in 1942 and is one of 165 similar college programs. The annual gift to alma mater from grads has become the leading choice of colleges in their attempts to remain solvent.

attempts to remain solvent. Last year 383,260 alumni gave \$9,628,-922.00 to their schools with the per person average of \$25,12.

The war years and the capital funds campaign for the dormitory have diverted much of the money we hope now can be allotted to the Willamette Loyalty Fund.

Our Willamette goal for this year is \$5,000. The association office has 3000 alumni addresses and each will receive this magazine.

We are making this appeal how as there is a greater general interest in "the old school" manifest during graduation time.

Everywhere colleges are heralding the news that young hopefuls are ending college days newspapers and magazines constantly remind us while commencement announcements are found frequently in the mail.

Certainly there must be times when in retrospect we return to the campus to again wear the cap and gown, to again remember Willamette and realize that another year has been completed. We know that you will enjoy that moment more if you have helped.

Unless Willamette is willing to stand still, which actually means to go backwards, substantial additions to her income must be developed.

# Little College, What Now?

In the history of higher education in the United States, there has never been a time when it is more important for some of the educational institutions of the country to emphasize quality rather than quantity in education.

Traditionally, Willamette University has been interested in quality education. The present plan and purpose of the University is to admit those students fully qualified to profit from the educational opportunities to be found at Willamette and to give these selected students the best possible instruction in liberal arts, music and law. In keeping with this ideal and program, Willamette University has resisted the temptation, during the past four years, of enlarging the enrollment to take care of more students than could be educated in the Willamette way.

From the standpoint of staff and equipment we are edequately prepared to take care of a thousand students. At present we have an enrollment of slightly over that number, but it is the purpose of the University to continue with the limited enrollment and to eventually return to the limits which have been established.

To do the best possible job with the present limitation, the University must add another \$3,000,000 to the endowment. Without this backlog of endowment support, the institution will find it necessary to charge higher tuition rates, which will eventually deprive many worthy students of the privileges of education on the Willamette campus. Western universities have not found it possible to build up large endowments comparable to eastern institutions. We are fortunate, at Willamette, in having one of the sizeable endowments in the west, but we should ever keep in mind the importance of increasing the financial backlog of the University. Friends and alumni are urged to consider the needs of the University, personally, and to make recommendations to those of their acquintance who might care to support a worthy program of higher education.

Recently a significant gift to liberal education was announced in southern California, when Mrs. Chauncey D. Clarke gave a large part of her estate to the Claremont college group, as a permanent endowment. In commenting upon Mrs. Clarke's gift, the Los Angeles Times wrote an interesting editorial which I quote:

"The imposing bequest of Mrs. Chauncey D. Clarke to Claremont College is especially significant at a time when the greater emphasis is on quantity rather than on quality.

The larger part of Mrs. Clarke's \$5,000,000 estate will be held by Claremont College as a permanent endowment. It was her conception that the income be used to bring to Claremont "some of the best minds of our times for the teaching of youth in an advanced program of humanistic learning."—to support the graduate school, which is common to the colleges of the Claremont group. No part of Mrs. Clarke's gift may be used for building or purchase of land. By the terms of the will, the money must be used for teaching and research.

There is a strong agitation, supported by the present Federal administration, to make "college education" a mass production item for almost everyone. The Federal program for support of education, broached last spring, said little about educatility; the age of a student seemed to be the chief qualification. If he weathers high school before he is old enough to be entitled to a pension, the probability is that he should be sent to college at Federal expense—the planners argue in some such wise.

If the dream of universal "college education" comes true, the standards of statesupported schools are bound to be reduced to meet the lowest common denominator of student intelligence. And in that case the privately endowed colleges—the ones that can reject the state subsidies and maintain standards of scholarship—will glow in the pervading gloom of learning like St. Columba's little colony of devotees on Iona

Mrs. Clarke's bequest to Claremont is said to be one of the largest gifts to higher education ever made in the West. Other wealthy persons, pondering the problem of making their money serve posterity best, might do well to fortify higher education in those places where it seems most willing to fight to preserve its aspirations and freedom."

Willamette is worthy of some outstanding gifts of the type Mrs. Clarke has made. These large bequests are not numerous and, in the meantime, the success of our financial program will depend upon many small gifts coming from those who love their Alma Mater and who can afford to give smaller annual gifts. The distinction of Willamette University is an asset to every graduate of Willamette. Every son and daughter can play a part, large or small, in the further development of the University.

# Alumni Don't Have to Be Useless

If you are a college alumnus, you probably want to know if your alma mater's football team will be ay good next season. That's fine. But if you are really fond of the old school, there are more practical things that you and your fellow alumni can do for her—and perform valuable public service at the same time. Most alumni do not realize this. Here is what you can do:

Interest outstanding high school students in anrolling.

Help raise money.

 Develop a community adult education program.

These things help your college as well as your community. Here is what educators have to say about them:

Selling your college to prospective students. Most important, keep yourself up to date on what is happening on your former campus. Be familiar with what your college has to offer high school students academically. Sometimes a bright student would like to attend your college and can't because of money difficulties. Know what scholarships or loan funds are available to him.

Check your high school principal on the bright and well-rounded people in his current graduating class. Talk to them, if possible, and learn their interests and ambitions. If the high school principal objects to this approach, try to set up a "Go To College" day or week in which prominent men in the community could tell the high school senior class about their own alma maters.

Many high schools already have such programs. Some colleges send their own representatives to them, but others can't afford to. You, as an alumnus in the community, can serve as representative.

Colleges usually look with favor upon prospective freshmen who have been recommended by outstanding alumni. Dartmouth relies almost relies almost exclusively upon the recommendations of alumni. Dickinson College in Carlisle, Pa., gets nearly 80 percent of its students from beyond a radius of 50 miles. And the college credits its far-flung alumni for this record.





Raining funds for your college. Many colleges have established alumni foundations which raise funds, both for general purposes and for specific uses, such as setting up a special chair of teaching or for research. University of Chicago alumni alone raise more than \$200,000 a year.

The President's Commission on Higher Education has reported gloomily on college finances—and one of the gloomiest aspects is the diminishing amount of revenue which colleges can count on from private gifts and grants. The big givers are not showing up as frequently as they once did. Colleges will have to look more and more to the small gifts from alumni and friends.

If you can't give money, you may have leads on people who can. Your own enthusiasm is a major factor in interesting others. Frequently, colleges dampen an alumnus' enthusiasm with their slipshod ways of raising mon-y. Alumni can help correct this. Joseph E. Bell, 1947 persident of the American Alumni Council, recently cited one of the major faults among colleges in their attitude toward fund-taising.

"Many colleges have not yet caught the definite and direct relationship between the small gift and the large gift", he said. "The gift from the young alumnus and the gift from the old alumnus. Some are led astrray by the great and handsom: gifts, we lose sight of their source. The men and women who make the substantial bequests once gave modest amounts. formed the habit of giving early and saw their small gifts made effective through collective giving."


Alumi with wide busilness experience can well advist their alma maters on some basic principles of fund-raising.

One inportant and worthwhile way to help your college financially while assuring it of a high level student body is to establish a local scholarship. The method of award, and to whom, would have to be discussed with local school authorities. But a group of alumni should be able to establish one or more annual scholar hips without too much expense.

Promoting adult education. The desire among adults to participate in some form of educational program was demonstrated recently in a Gallup Poll. Two out of five adults want to attend adult classes of some sort. Alumni groups can lead in establishing such programs, and thus perform a valuable community service redounding to the credit of their alma mater.

If no adult education program exists in your community, you can help get one starterd. If there is a college or junior college in town, the problem is fairly simple. Many colleges are eager to lend their facilities and provide personnol for evening classes at little cost. Almost all colleges are ready to provide guidance and background material for a community which wants to get a program started. If there is no college in town, your own college may provide materials and guidance.

Formal classes constitute only one method in adult education. The University of Chicago and St. John's College at Annapolis sponsor reading programs. In Washington, a group of newspapermen and government officials are reading a series of books on political philosophy. Once a week they meet to discus ther reading among themselves and a St. John's professor. They each pay \$10 for a 12-week course.



On the negative side, alumni are a source of irritation to educators on one major count: Too many alumni ate chronic beefers who don't keep themselves informed on what their college is doing. Their gripes are usually based on performance on the athletic field. So they exert pressure to fire coaches who don't show up with winning teams. At homecoming day, their main attraction is often the old fraternity house, where some may wind up drunk. For many a college president, the happiest day of the school year is the day after homecoming day.

Mr. Bell puts it this way:

'Every college has its share of juvenile alumni, men and women who thing that fraternities, or intercollegiate sports, or smokers, or dramatics, or reunions—important as they are—are more important than the college itself. It must be made plain to these alumni that the great task of American colleges is that of training young America.

The choice that is open to all alumni is pretty well summed up by Dr. Roswell Ham, president of Mount Holyoke College.

"You can be a pain in the neck," he told some college graduates recently, "or you can be the greatest aid in the world.

# Mr. Fenix, I Have a Problem

Many requests have come to me asking for explanation of the activities of our office and the part that finances play in the operation of educational institutions, and Willamette University in particular. It is the policy and practice of this office to try to furnish the best possible business service to the faculty and students of the University with the available funds. Every effort is made to operate efficiently but to keep in step with the educational progress, and efforts are made to see that the efficiency does not interfere with but aids our educational program. As most of you know arrangements with the students to fiance their education through deferred payments when necessary. The loan funds have been used more during the past year than any year since the latter part of the depression. Scholarships are being called for more each semester. Several friends of the University and several organizations, such as, service clubs, churches, fraternal orders and women's societies have furnished scholarship funds or are furnishing annual scholarships ranging from \$100,00 a year to 400,00 per year. Loan funds and scholarship funds would be very welcome to make it possible for needy and worthy students to continue their education.

Another activity of a similar nature is the handling of the Student Body business. The business office works with the students manager, and the general manager of the Associated Students to carry on the busineess activities of the Associated Students. We find that this service gives a continuity and a consulting financial service which aids the students in their activities.

During the last few years the business office has worked with the director of athletics and his staff in handling the business side of athletics. We have tried to provide facilities, equipment, and supplies that will improve our athletic program. We have made great efforts to aid the athletic department in offering a better program of which the alumni can be proud. At the present time funds are needed for the completion of Bush's Park Athletic Field. As many of you know we have one of the finest turfed and drained fields in the northwest. Even during the heaviest downpour the water has drained off through the natural drainage and the drainage system which was constructed before the turf was seeded. Through the gifts of the alumni and friends the field has been turfed and a regular athletic fence has been erected around the entire field. A recent gift has made it possible for us to start construction on the track. This will make it possible to put in cement curbs on both sides of the quarter mile track and 220 yard straight away, as well as to haul the coal cinders for the top layer of the track. Additional funds are needed now to finish the con-struction of the track. We hope that these funds will be available so that we will have our track and baseball activities on Bush's Park this season. Funds will be needed for the sidewalks, roadways, tennis courts, lights, scoreboard, and more funds are needed in order to have enough to construct the grandstand.

Another activity of the business office is to handle the payments of accounts payable and the payroll. The current budget will run close to two-thirds of a million dollars during this year. At the present time we have 188 regular, full-time employees and over a 100 student

employees with a monthly payroll of approximately \$33,000.00. Every effort is made to make purchases and handle our employees as effectively as possible to get the most for our educational dollar; however, inflation has hit business activities of the institution severely. In order to properly compensate our employees, including the faculty, it is necessary to improve salaries. All services and supplies purchased have increased in price as business men and housewives know. Another activity of the business office is to work with the Endowment Committee of the Board of Trustees and the President in the handling of our Endowment. The University has an Endowment Fund, which including recent gifts of property, would have a value of over two million dollars. From time to time additions have been made to the Endowment Fund by friends of the University. which could provide current funds that would be of great value to the University. For in-stance, 100 friends giving \$100,00 each or 400 friends giving \$25,00 each could furnish \$10,000.00 per year which would be equal to the income that would be available from \$250,000.00 in the Endowment Fund. This illustration may be varied but can be used to show the current value of many gifts from many friends in improving our educational services

The Financial Vice-President is very anxious

to work with the President and alumni of the University to improve our services to the University.

As you know only the net income from these funds is available for the operation of the University. As many business men know the rates of return, such as a six percent invest-ment, that were available in the past are no longer available. With prudent management on the part of the Endowment Committee our investments of the Endowment Funds have earned approximately four per cent on the funds invested. This is an excellent showing in view of the current interest rates. In order to continue to offer the fine educational service that Willamette has offered in the past and to maintain our position as the leading Liberal Arts College of the northwest more endowment funds and loyalty funds will be needed in the future. Large additions are needed for the Endowment Fund, the income from which can be used for scholarships, faculty salaries, and operating expenses. Friends may endow faculty chairs and in this way improve faculty salaries. However, there is another method which is being used in other educational institutions to finance current operating expenses. This method is to arrange for annual gifts from many loyal friends of the University

During the past few years we have made serious efforts to beautify the campus and to redecorate the buildings. Each years funds have been allotted to improve the campus, so that now the entire campus is completely landscaped from State Street to the mill stream. Within the next year or so, shrubbery will be added to the area around Baxter Hall and Chresto Cottage. Lausanne Hall, Waller Hall. and Eaton Hall have been completely decorated New lighting has been installed in the classroom buildings and the library in order to give the recommended footcandles for the proper study. The educational procedures have been improved by the addition of audio-visual aids in the form of equipment and rooms. Slide projectors, movie projectors, tape re-corders, wire recorders, phonographs, sound projectors, turntables, microphones have been lurnished in order to help the professors bring the latest in audio-visual aids to the students.

Great efforts went into the construction of Baxter Hall so as to give the men students proper housing which has been needed for so long. Many gifts from friends of the Univer-sity made this possible. This fine building was constructed in a little over ten month. was constructed in a little over ten month, at a time when there were restrictions and shortages of many kinds. A great deal of effort was required to obtain materials, equipment, and supplies in order to finish this building. It apparently was built at just the right time as a recent survey indicates that this would be a million dollar building today. In order to built it for 1948 a bank loan was floated to built it for 1948 a bank loan was floated. Gifts from friends of the University have been very helpful in reducing this loan. However, more gifts are needed now to complete this project financially. Arrangements were made with the Federal Works Administration to build on the campus a tine health service building, an art building, and a music hall annex building which is used for band and orchestra teaching and practice. There are other buildings needed on our campus in order to give the best possible educational service in the north west. Several new buildings are needed such as, a new women's domitory, a liberal arts classroom building, a worship chapel, a fine arts building and auditorium, and a student union building. A new field house and a man's gymnasium would be a great asset to our athletic activities. Such buildings will only come through the generosity of the friends of Willamette.

Another activity in the line of our business service is in the supervision of the auxiliary enterprises. The business office works with the various managers to give housing and good service to the students in the dormitories, the cafeteria, and dining halls. The Bookstore has been enlarged and redecorated and many new lines have been added to make this institution of great service to the students. The Bearcat Cavern has been redecorated and the service improved so that the students will have a students center on the campus. New furniture is badly needed for this institution. Through a recent gift of an alumnus of the University a set of folding bleachers has been installed in the gymnasium. These are sturdy and comfortable and very flexible. This gift will make it possible to have our regular chapel and student body meeting on Tuesdays with the entire student body together in the gymnasium. These bleachers are going to be a real service during the Freshman Glee and Commence-

# DEPARTMENT ENROLLMENT

The program of the Education Department of Willamette University is attracting increasing numbers of students. The total individuals enrolled ,and the total enrollment in Education classes is the highest that it has been for a long time.

The figures for the Fall Semester, 1948, show that there are a total of 148 individuals taking at least one education calss. This is about one person in four who are eligible to enroll, as only upper division and graduate students may take work in this department.

The Department, recognizing the problem that these large enrollment present to the University, and also having data which seem to indicate that the supply of certificated high school teachers is now almost entirely adequate to the demand in Oregon, have set up certain standards for admission to and continuation in the Teacher-Training program.

## MEN OF '38 - GOOD BET

The results of a survey of the children of college graduates indicate that the men of class of 1938 have produced 2.32 children per parent who reported. This percentage is the fourth highest nationally in 84 colleges reporting. Approximately 91% of the marriages have produced children. Reports were received from 84 grads.

The women of '38 were 68th in the ratings with 1.75 and 63 reporting.

The class of '23 also participated in this survey and the men (93) ranked 16th with 2.21 while the women (86) were 23rd with 2.17. Utab State had the high with an average of 3.18 for women and 3.05 for men. At present a survey is being made of the classes of '24 and '39.

Since the passing of L. Franklin Belknap and Henry Jones, the alumni office has been unable to determine who can claim the title of the oldest living graduate of Willamette University.

## AN ALUMNI MAGAZINE

This issue of the Alumnus is an experiment-an illustrative example of a possible future Alumni magazine.

Willamette is at present unable to send a magazine of this type on a quarterly basis to all grads which is the wish of the Alumni Association. This demonstrative issue was made possible by suspending publications of the Fall and Winter issues and using those funds in addition to those of this quarter.

Estimates from a recent survey indicate that over 350 of the 1,700 American colleges and universities have alumni magazines with over 1,725,000 readers. There are 62 magazines that appear monthy against 92 who favor the quarterly period while 24 print 3 issues or less a year. The balance follows varying plans.

Cost varies from Harvard's \$50,000 yearly budget to a few hundred dollars and these expenses are met in various ways. Some colleges send their publications gratis to all grads. Only Alumni fund contributors receive the magazine in some schools while subscriptions are sold in others.

All Alumni of Willamette who's correct address is in the Alumni stencil file (3000) have been receiving publications of that office.

The cost of this issue is about \$350.00. The Alumni office is vitally interested

in your reaction to an alumni publication. With an increase of general support by Willamette grads such a magazine could be possible on a quarterly basis.

# Now Is The Time For All Loyal Alumni

- L Q. What is a living endowment?
  - A. A Living Endowment is made up of annual gifts which may be applied to the current expenses of the University. Regular endowments depend upon income from investments to be used for university expenses. Your annual loyalty gift is the income to be used. An annual Loyalty Fund of \$10,000 is equal to the income from a permanent endowment of \$250,000.
- 2. Q. What is the purpose of the Willamette Fund of Living Endowment?
  - A. The purpose of the fund is to secure in each year from Alumni and friends of the University, contributions to be used solely for educational purposes.
- 3. Q. Who administers the Loyalty Fund?
  - A. The Directors of the Willamette Fund are composed of the President, President-elect, and secretary-treasurer of the Willamette Alumni Association, the six trustees of the University who are elected by the alumni, the President of the University, and as many as six additional members elected by the above named directors.
- 4. Q. May the University use the money without consulting the Directors of the Fund?
  - A. No, all appropriations for the Willamette Fund must be voted by the Directors of the Fund.
- 5. Q. May I subscribe to the Willamette Fund and make payments in monthly installments?
  - A. Yes, subscriptions may be paid in any way desired, so they are completed by June 30th of each vear.
- 6. Q. May I make a subscription to be paid over a period of several years?
  - A. No. each subscription is paid in full each year. None are carried over. New subscriptions are solicited each year.
- 7. Q. Are gifts to the Willamette Fund deductible for income tax purposes?
  - A. Yes, since the fund is used only for the educational purposes of the University and payments are m-de directly to the University as custodian, gifts to the fund are deductible when making income tax returns.
- 8. Q. In what amounts may gifts be made to the Willamette Fund?
  - A. Gifts to the Willamette Fund are in units of \$5.00. Ten units would provide a gift of \$50.00 and 20 units a gift of \$100.00.
- 9. Q. Will a gift to the Willamette Fund make a graduate a member of the Willametre Alumni Association?
  - A. Yes, a gift of one or more five dollar units automatically carries with it membership in the Willamette University Alumni Association for all who would ordinarily be entitled to such membership.

- 10. Q. What are the requisites for membership in the Willamette University Alumni Association?
  - A. Be a graduate of Willamette or have attended any of the divisions of the University two-for more years.
- 11. Q. How are expenses met for the solicitation af the Willamette Fund? Ér.
  - A. The headquarters of the fund is in the Alumni Office which is financed by the regular budget of the University. Mailing and other operation expenses for collecting the find are budgeted by the Directors of the Fund and paid from monty contributed and collected by the Willamer 8 Fund.
- Q. What other expenses are paid out of the Fund? X
   A. None, all other money contributed is available to be appropriated by the Directors for the educational use of the University.
- 13. Q. Are appropriations made to the University before the money is collected by the Fund?
  - A. No, the Directors may appropriate only money which has been collected by the Fund and deposited to the Account of the Fund.
- 14. Q. May a gift to the Willamette Fund be restricted for a specific purpose?
  - A. Yes, a gift of 40 units (\$200) may be used to create a full tuition scholarship for one year. In such instances the donor must specifically designute his desire to create the scholarship at the time the contribution is made to the fund. All contributions not so designated will be deposited to the fund, to be administered as stated in answers two and three
- 15. Q. How are the scholarships to be granted which are thus created?
  - A. Scholarships created by gifts to the Willamette Loyalty Fund are authorized by the Directors of the Fund and awarded by the regular faculty committee on scholarships of the University.
- 16. Q. May War Bonds be given as contributions to the Fund?
  - A. Yes, War Bonds are acceptable and will be held to maturity. If cash money is required by the Fund, the War Bonds can be transferred to use of the Trust Funds of the University in return for cash to be deposited to the Fund. Bonds for the Fund must be series F or G made out in the nume of the Willamette Loyalty Fund of Willamette University.
- 17. Q. Will a gift this year to the Willamette Fund obligate me in future years?
  - A. Each year is complete in itself. There is no obligation for the future, but Alumni and friends are urged to make annual contributions, 'Put Willamette in Your Budget".
- 18. Q. To whom are contributions sent?
  - A. All payments are made direct to Willamette University and are deposited in the Business office to the account of the Loyalty Fund.
