Around the Campus . . .

Willamette's forensic program has achieved recognition in the newly published textbook, "Argumentation and Debate," released this month by Dryden Press of New York City. Representing the university, in a model "cross examination debate" are Thomas Scheidel and James Wood, both 1952 graduates. The topic covered—"Resolved: That the Congress of the United States should enact a compulsory fair employment law"—was the national subject during the 1952-53 season. Scheidel, now a teaching assistant in speech at the University of Washington, won the unprecedented distinction of being invited to participate in the National Invitational Tournament at West Point, N. Y. for three successive years. Wood, now a teaching assistant at the University of Oregon, was a contestant in the West Point tourney in 1953.

A 25-year testimonial luncheon was given in honor of Dr. Roy M. Lockenour, professor of law, by 125 alumni, students and faculty members May 5. W. W. Balderree, 1933 gradu-

ate of the College of Law and former president of the Oregon State Bar Association, was principal speaker for the event. Dr. Lockenour, who will retire in June, was named professor of law at Willamette in 1928. He served as acting dean of the law school from 1932 to 1940.

One hundred students paid tribute to Dr. Robert M. Haley, head of the economics department, at a surprise testimonial dinner May 4. Students from all of the educator's classes were present for the event. Dr. Haley, who will retire in June, began

his teaching career 33 years ago.

A legislative workshop program, the first on the West Coast, will be introduced by the College of Law in September. Samuel R. Haley, legislative counsel for the State of Oregon, has been appointed chairman of the program and will be a part-time instructor on the law school staff. Purpose of the legislative workshop is to offer students the fundamentals of statute interpretation and construction. "Our hope is to train the students to assist in the actual legislative process," said Haley, "so that members of the legislature or legislative committees wishing to utilize the services of trained students for research may do so."

Judson Jones, the freshman whizz from Portland, gained the ranks of Willamette track immortals as he set a new all-time WU 440 mark in a three-way meet at Forest Grove in late April. Jones romped the quarter-mile in a torrid: 50.3 to better the former mark of: 51.6, held by himself and by Rein Jackson, '21, now principal of Portland's Cleveland high school (his two sons, Jim and David are both enrolled at Willamette.)

The third annual federal inspection of the AFROTC detachment was completed April 27, with the trio of inspecting officers "very pleased." No official results of the inspection were released, although relations of the department with the university, orientation flight program and the cadet corps' military review were cited as considerably above average.

Robert W. Fenix, financial vice-president and business manager since 1943, has been appointed comptroller at Occidental college in Los Angeles, it was disclosed this week by President Arthur G. Coons.

Fenix will remain at Willamette until the end of the fiscal year, June 30, and will assume his new duties at Occidental in August

in August.

secretary of the Rotary club for nine years.



Two Grads on Three-Man Inventing Team of First Solar Battery

Two of the three-member inventing team of the solar battery—first successful device to convert useful amounts of the sun's energy directly and efficiently into electricity—are Willamette University graduates.

They are G. L. Pearson, physicist who received his BA degree in 1926, and Daryl M. Chapin, electrical engineer, who was granted a BA degree in 1927. The third inventor, chemist Calvin S. Fuller, holds BS and PhD degrees from the University of Chicago.

Scientists at Bell Telephone Laboratories in late April showed how the sun's rays could be used to power the transmission of voices over telephone wires. The Bell solar battery also used energy from the sun to power a transistor radio transmitter carrying both speech and music.

Developed by the three-member team of scientists, the experimental solar battery uses strips of wafer-thin silicon about the size of common razor blades. These strips are extremely sensitive to light. They can be electrically linked together and can deliver power from the sun at the rate of 50 watts per square yard of surface.

The eastern laboratories reported that it was able to achieve a 6 per cent efficiency in converting sunlight directly into electricity. This compares favorably with the efficiency of steam and gasoline engines, in contrast with other photoelectric devices which have never been rated higher than 1 per cent.

Pearson became a member of the Bell Telephone Laboratories Physical Research department in 1929, spending his early years at the laboratories on studies of noise in resistors, vacuum tubes and carbon microphones. Except for a brief period during World War II, when he was engaged in work on military projects, he has since concentrated on semiconductor research. In this field he has been concerned with thermistors, transistors, and more recently, silicon rectifiers which led to the invention of the solar battery.

Chapin, a member of Bell laboratories since 1930, was first concerned with magnetic materials and, during World War II, with underwater acoustics. Following three years of work on magnetic measurement, miniaturization, pulse code transmission, and simulated speech, he has been concerned more recently with engineering aspects of the invention of the solar battery.

Columbia U Added To 3-2 Engineering Plan

Columbia University was unanimously approved by faculty members this week as the first east coast school to be included in Willamette's 3-2 engineering plan, which already maintains programs with Carnegie Institute of Technology at Pittsburgh, Stanford University and the University of Southern California.

"Affiliation with Columbia University now gives our students a wide choice of outstanding engineering schools on the west coast, middle west and in the east," said Liberal Arts Dean Robert Gregg.

The 3-2 plan calls for three years at Willamette with completion of all lower division requirements and a major in some field of science plus a few courses suggested by the engineering school itself.

At the end of three years, the student in the program enters the engineering college of his choice and spends two years in specialized study. At the conclusion of the five-year program, he receives both BA and BS degrees.

Ex-Editor of Slovak Daily Named Economics Head

Dr. Vojtech E. Andic, former editor of the Slovak Daily and associate editor of the Czechoslovak Press Bureau in New York, has been appointed associate professor and chairman of the economics department.

Currently on the business administration staff at Milton college in Wisconsin, the educator will assume his new position at Willamette June 14, when summer session begins. He resigned a Lisle Fellowship for summer study in Washington, D.C., to accept the university post

Dr. Andic, who became a naturalized citizen in 1942, took asylum in this country at the time of the Communist coup in Czechoslovakia. He served as Czechoslovak consulate member for cultural and press relations and as a scriptwriter and announced for Czechoslovak Shortwave Broadcast from 1941-48.

From 1949 until 1954, the educator was on the U.S. information agency staff of International Broadcasting program, working as a foreign information specialist, scriptwriter and announcer.

He holds a MA degree from Columbia University and a PhD degree from New York University. In 1932 he received his teacher's certificate for commercial colleges from the University of Prague School of Buisness Administration.

Preparations Underway For NY Giants Showing

Preparations already are commencing for the appearance of the New York football Giants here July 15th to start their pre-season drills, utilizing Baxter hall for housing accommodations and McCulloch Stadium for pre-season workouts. The pro grid club will number 70 persons when it arrives in Salem, under the mentorship of Head Coach Jim Lee Howell, a former Giant player great.

At last reports, the Giants had 40 men under contract, with more to come. Among the signees are three quarterback candidates who attained All-American statute while in college.

The trio are Arnie Galiffa, one-time Army ace; Don Heinrich, University of Washington's great passer of a few season's ago who has just been released from the service; and Chuck Conerly, another passing whizz.

Among the top ball packers are Frank Gifford, Eddie Price and Kyle Rote. Gifford gained the headlines at Southern California and Rote will be remembered as the Southern Methodist great.

Viesko & Post Offer Low Bid on Buildings

Viesko and Post, Salem contractors, offered the base bid for the construction of Willamette University's three new buildings at a meeting of the building and executive committees this week in Salem. The building committee voted to recommend to the board of trustees that the contract be awarded to the low

The local contractors presented the low bid at \$1,050,500. The total amount for the over-all project, with alternates plus equipment and architect's fee, will reach \$1,150,000.

The contract will provide for the construction of a women's dormitory, an auditorium fine arts building and a health center.

First major goal in the Willamette challenge fund was reached this week, announced Fres. G. Herbert Smith, with \$325,000 subscribed to the campaign. Realization of this sum entitles the committee to claim an equal amount in pledged matching funds.

Earlier in the university campaign, \$500,000 had been pledged in contingent gifts to be made available when an equal sum was raised. An initial amount of \$625,000 was required before bids for construction might be considered.

The campaign for \$1,000,000 will continue until its completion, said Pres.

Willamette's million dollar building project was launched in May, 1953, following authorization of the board of trustees at the mid-year meeting in February, 1953.

The health center will be erected on the Willamette campus by the family of the late Mr. and Mrs. C. P. Bishop as a memorial to the elder Bishops who were identified with the university and active in Oregon business for many years.

Professors Lead Tours To Europe, Mexico

Europe and Mexico are beckoning Willamette professors who will lead organized tours into the far away places this summer. In cooperation with Stu-dent International Travel association, Willamette will sponsor three European

Dr. George Hocking, veteran of several French study tours, will again lead a group to France for study at the University of Grenoble, Approximately 30 students from all parts of the United States will join Dr. Hocking's tour. Prof. Clarence Kraft, in his first ex-

perience leading a foreign tour, will conduct the SITA Spanish study group to

the University of Stantander.

Dean Mark Hatfield's political science expedition, also under auspices of SITA, will include five Willamette men who will study the various forms of European governments in England, France, Germany, Yugoslavia, Spain and Greece. Highlights will be talks with Marshall Tito in Yugoslavia and Premier Franco in Spain.

Dr. Thomas Bennett is conducting an independent study tour to Europe which includes 11 Willamette students. They will travel by bicycle. Early-awake Salemites have witnessed Dr. Bennett and his tour members getting in condition for their sojourn with 5 a.m. cycle workouts

A four-week tour to La Paz, Mexico, directed by Dr. Paul Beal and the Hanna Travel agency, has been approved for credit by the faculty and will be conducted if enough interest is shown. Students will visit outlying areas and be expected to write a paper on some phase of Latin culture while in Mexico.

WU Hosts Western Law School Conference

Prominent educators of law in ten western states comprising the Confer-ence of Western Law Schools, under the chairmanship of Dean Seward Reese, met in Salem for the first time May 7-8 to discuss pertinent problems confronting legal education today

Secretary of Interior Douglas McKay was guest speaker at the Saturday luncheon meeting. Sheldon D. Elliott, president of the Association of American Law Schools and professor of law at New York university, was principal speaker at Friday's banquet.

Problems under discussion at the twoday conference included: classroom teaching techniques; treatment of borderline academic cases; first year curriculum-its aims, objectives, content and method; and experiments in teaching professional responsibility

Largest coast conference to date, more than 70 law school representatives were

in attendance.

Holmer, Students Aid National Analysis

Release of the five-volume study of the 1952 presidential campaign compiled by Brookings Institute this week brought national recognition to Prof. A. Freeman Holmer and four former students in the Willamette political science department.

The men prepared a pre-convention case study of the Oregon delegation to the Republican convention and the GOP's preferential primary in this state. A similar study of the democratic side of the picture was made by Prof. Waldo Schumacher of the University of Oregon.

Studies were also made in all states, Alaska and Hawaii to show how both parties selected their candidates. Locally prepared evaluations of the political temperment in the various states are also included. Over 340 political scientists contributed to the extensive political analysis published this week by the John Hopkins Press in Baltimore.

Assisting Holmer in the preparation of the Republican aspects of the Oregon chapter were students Joe Benninghoff, now a graduate student here; Eldon Caley and William P. Merriam, both at the College of Law; and Robert L. Small, currently with the United States Navy.

Holmer, associate professor of business administration, was chairman of the state Young Republican organization at the time of the work. He is now chairman of the Oregon Citizenship Clearing House.
