



MEETINGS DEAL WITH PROBLEMS OF LAW SCHOOL

Requirements Will Probably Include One Year's Preparation in Liberal Arts

DAY SCHOOL MAY RESULT

Endowment Drive Contemplated on Completion of Willamette Campaign for Million

Two distinct steps in the development of the Willamette Law School were taken as the result of meetings held recently, one by the law faculty, who expressed sentiment in favor of increasing law school requirements to one year of liberal arts, and one by the Willamette Board of Trustees, wherein the matter of an endowment campaign for the law school was discussed.

Although no definite or formal action was taken by the law faculty at the time of the meeting, every member was in favor of such action, as it was pointed out that without a doubt a liberal arts course of at least one year would better qualify a student for the study of law, and at the same time, make him more efficient upon graduation. Another reason for desiring the one year liberal arts requirement is that the Association of American Law Schools, beginning next year, will take as members only schools which have as an entrance requirement a one year liberal arts course. Willamette is not a member of this organization as yet, due to the fact that it cannot meet the requirements.

Question of Endowment Raised At the meeting of the Board of Trustees of the Willamette University, President Doney appointed a committee, of which Attorney-General Van Winkle was named as chairman, to consider plans for the promotion of an endowment campaign for the law school. Nothing will be undertaken, however, until the endowment campaign for the Willamette University has been successfully completed. The law school has an enthusiastic and loyal alumni who will use their best efforts to see that the campaign is put over, and a sufficient amount of money raised to place the school on a firm financial basis, so as to permit expansion. An endowment will also make it possible for the school to become a member of the National Association, which requires that the school seeking membership have at least three full time instructors; to have classes during the day, thus eliminating night school; and to have a library of at least five thousand volumes. At the present time, the Willamette Law School has not a single full-time instructor, but depends entirely upon the work of twelve local attorneys. These attorneys can only hold classes from five to six in the evening, due to the fact that they cannot leave their business during the day. Too, the school does not maintain any library to speak of.

Law School Ranks High In spite of all these handicaps, the school ranks very high in scholarship. In the State Bar examinations which were held recently, 9 Willamette Law School graduates took the test. Eight of these men passed the examination, and the failure of the ninth one was entirely due to the fact of poor work on his own part, and not to any fault of the faculty or the school. Sixty-eight men, altogether, took the State examinations, 25 per cent failing to pass. This places Willamette on a high basis in point of comparison, as only twelve and one-half per cent of Willamette's graduates failed. The Willamette law school has been in operation since 1883, and numbers among its graduates many prominent characters throughout the West, among whom are Judge McCourt, of the local Supreme Court; Attorney-General Van Winkle; and Judge Alfish, of Idaho.

Mr. Ray L. Smith, secretary of the law school, when interviewed, expressed his faith in Willamette's law department, and stated that should the endowment campaign go over satisfactorily, it would be but a few years before Willamette would be recognized by the National Association of Law Schools. CHAMPOEG TRIP MADE BY CLASS

Professor Gatke Takes Oregon History Students on First Visit to Historic Site

The first of a series of excursions was made on Tuesday afternoon at 4 p.m., under the chaperonage of Miss Pierce of the English department and under the directorship of Professor Gatke.

The party, which numbered thirty-five, the smallest number ever taken on this trip, was conveyed in seven automobiles to Champoege, the site where the first Oregon provisional government was adopted.

At the time of the meeting, the early part of 1840, Champoege was a little French village utilized and controlled exclusively by the famous Hudson Bay company as a loading dock for wheat. The meeting was actually held in a part of the warehouse, and as no decision was ultimately arrived at the meeting broke into a wild discord.

While the people were in the front of the house, Joe Meek, an American, called for a new vote, and the side in favor of the American government won by two votes—thus including Oregon in the Union and finally defeating the foreign policy of Great Britain in America.

The present site of Champoege is marked by a state memorial building, whose caretaker is an eminent French artist, who has painted a picture depicting the famous scene of the adoption of the American constitution.

Champoege was swept away by floods in the early sixties, and the numerous remains of the villages are all extinct.

After a period of research the remainder of the evening was spent around campfires, over a well prepared supper, and Professor Gatke with the unanimous assent of the entire party, delightfully indulged in popular Willamette songs.

FORENSIC TEAM CINCH DEBATES

Deficit of \$200 is Assured by Student Body Action ERICKSON TO BE COACH

Fifteen Letters Go to Schools Seeking Contracts

Acting on the promise of the student body to secure the necessary \$200 allowance for the forensic fund, the forensic council yesterday mailed fifteen letters to as many schools, en route the prepared trip, with the object in view of closing final arrangements for debates with ten of the fifteen. The only thing blocking the trip now, according to the statement of Chairman Littler, of the forensic council, is the \$200 subscription which must be secured by outside pledges.

It was the original plan to secure \$500 by outside pledges. Two hundred of this has already been pledged and the rest is being solicited by the members of the council. They hope to have the last dollar pledged in not more than two weeks. The action of the student body concerning the \$200 came through a resolution presented by Robert Notson, representing the executive committee which assured the forensic council that the \$200 lacking in the budget appropriation would be raised. The resolution passed unanimously.

The fifteen letters sent out went to the following schools: University of Montana, Montana State College, Montana Wesleyan, University of North Dakota, North Dakota Agricultural College, Wheaton College, Upper Iowa University, Simpson College, Morningside College, Lawrence College, Ripon College, Redlands University and the University of Southern California.

It has been recently learned that last year Ripon College debated Bates College of Maine for the U. S. championship and that this year Ripon has scheduled a contest with Oxford University of England.

Professor Erickson, coach of the debate squad, has made no announcement concerning the progress of the men, although it is understood that many of the squad members are carrying on research work.

The question for the trip rests between two possibilities: Resolved—That the United States should adopt the cabinet-parliamentary form of government; and Resolved—That the United States should enter the League of Nations at once.

Sunday, October 22, marked the opening of Willamette University's two-month campaign for the subscribing of one and one-quarter millions of dollars, one million of which will be used as a permanent endowment fund and the other two hundred and fifty thousand for the payment of current expenses.

With a three hundred and fifty thousand dollar conditional gift from the Rockefeller Foundation and a total of about two hundred and fifty thousand more in individual pledges, also conditional upon the raising of the entire amount, the future indeed looks bright for Willamette.

On the opening Sunday of the campaign, pastors throughout the Oregon Conference changed pulpits and congregations in order, if possible, to lay greater stress upon the Willamette University drive. In addition to the work of the pastors, from eight to ten men are giving their entire time. LINFIELD TEAM DEFEATED IN A LISTLESS GAME

Bearcats Have Little Difficulty in Winning Informal Clash 26 to 0

CHEMAWA ON SATURDAY

Work of Inexperienced Substitutes Prevents Large Score; Zeller Whole Offensive

Not much real football was in evidence when the Bearcats met and defeated the Linfield College eleven 26 to 0 in an informal game on Sweetland field Saturday. Aside from several spectacular runs by Zeller the play was listless and slow. The Willamette backs and line made good yardage when they wanted to, but lacked the punch to run up a large score against their scrappy though green opponents.

The game was no more than was announced—a practice affair. It was the first football experience for Linfield in 15 years. Although outclassed badly, the McMinnville outfit put up a game fight. In comparison, the work of the Willamette team lacked the spirit of former games. Bohler introduced a second string backfield and made several substitutions on the line at the end of the first period and continued this line-up till the last quarter, when a threatening Linfield score caused him to rush in his reserves.

Willamette opened the game by Patton kicking forty-five yards to Wilson. Linfield could make no yardage, and a thirty-yard punt put the ball in Willamette's possession on Linfield's 45-yard line. On the first play Zeller went through for a touchdown. The next score, which came a few minutes later, was a duplicate of the first with the distance increased to 70 yards. Before the quarter ended, another score had been made by consistent line plunges for large gains. Score: 20 to 0.

The final score came in the last quarter after Zeller had returned to the game. Linfield had intercepted a pass and had advanced within the ten-yard line. The return of first string men to the line-up averted a score, when Linfield in a desperate attempt passed across the goal line. The ball was in Willamette's possession on their own 20-yard line. From this position Zeller again broke away for a touchdown after an 80-yard run. Aside from this one time Linfield never threatened the Willamette goal.

Logan played his first game at end and showed up to advantage in making two tackles—one for a four-yard loss and the other with Jones' assistance for ten-yard loss. His lack of experience coupled with the poor judgment of Caughlan allowed a Linfield runner to sneak around end for 35 yards.

Bird was given an opportunity to show his goods at tackle and probably earned himself a permanent berth. What this Wenatchee wino lacks in weight he makes up in aggressiveness.

Next Saturday the Bearcats are to meet Chemawa on Sweetland field. This is not expected to be much of a game as Salem High took the Indiana into camp a week ago Saturday by a score of 41 to 9. Chemawa has lost most of her veteran players and cannot be expected to put up the battle of former years. Bohler states that he is about done experimenting, and may use his first string throughout the game in an effort to

STAY ON THE JOB

The business men of Salem, through the Y. M. C. A. organization, and the registrar's office, have endeavored to assist students by offering to them part-time employment. Such cooperation by the townspeople is to many students the only means whereby financial support in the college course can be obtained. The complaint has come, however, that young men who take employment are not faithful to the trust placed in them. Some accept jobs and fail to appear to perform the work; others work part of the time required, and abandon their charge, leaving the employer to search for some one else to complete it. In one way or another they demonstrate that they are not reliable.

Such students do not merit the assistance of the Salem business men; but the penalty for their want of dependability does not fall upon them. The deserving student next to seek for work may be refused, because his fellow has established the belief that Willamette students cannot be depended upon. It is the old story of the innocent suffering for the guilty, and the failure of the careless individual to realize that in breaking his contract he is sinning against his fellow-man.

As matters trend at present, there will soon be a dearth of employment offers, unless those who contract for them show greater earnestness in performing their part in the bargain.

VACHEL LINDSAY—"THE ROBIN OF AMERICAN POETRY"

Vachel Lindsay is perhaps known by a greater variety of designations than any other living American poet. And each designation expresses a part of him. First of all he is "America's Tramp Poet" and "The Twentieth Century Minstrel." He roams and roves and wonderingly wanders, touching the soul of American folk, and out of the deep well of his experience he writes and speaks and sings. He once tramped across the continent making, and for his living, vending his poems. He has worked side by side with the harvester in the Kansas fields, tramped with tramps, communed with drunken sailors, conversed with evangelists, reasoned with the pedagogue, dined with the politician—all classes of society he touches, loves to touch, with the freedom and spontaneity of his being, that he may know and of them speak. For this he is called "The Great American Democrat." He perhaps knows the whole gamut of American life as no other poet of modern times. In this he is to be compared with Walt Whitman.

For his intense passion for beauty he is known as "The Evangelist of Beauty." But his "beauty," whether in drawings or in poems, reveals an originality and strangeness all its own. It is not the beauty of form or polish, but that of ruggedness, the beauty of vigor. It is not the pristine beauty of nature, as in Robert Frost, but the pristine beauty in life, in human nature, in man that interests Vachel Lindsay. His art, too, is strange; it presents a native grotesqueness which is startling. But to soften and improve away the blemishes of his poems is to weaken them. His art is not that of form, but that of sound. To get the full message of his poetry it must be read aloud. It rings with originality and pictorial beauty; the originality and beauty of marching, with all its rugged music.

Those who know him personally declare Lindsay an irresistibly genial personality. "It is impossible to quarrel with him," declares one who knows him well. He is honest, at all times sincere. He lives what he hopes America to be. Brought up in a strictly religious atmosphere, he maintains an interest in religious matters and is intensely religious. He is a mystic in the larger sense of that word.

For his generation he has a distinct message. Frank Glenn, editor of the Century Magazine, calls him "The Robin of American Poetry." In so calling him this critic emphasizes the fact that Lindsay is a force in American affairs "making for a less materialistic America."

He is the author of a number of volumes of poems, most noted of which are his "The Congo and Other Poems," "The Chinese Nightingale and Other Poems," "General William Booth Enters Into Heaven, and Other Poems"—all of which have proven popular. Among his best known single poems are those whose names appear in the titles of his collections of poems. One of his most popular is "In Praise of Johnny Appleseed."

We are fortunate in having Vachel Lindsay in Salem and at Willamette next Friday evening. It will be recalled that last year he was forced to cancel his appointment with us by the sudden death of his mother. The interest evinced at that time and already shown this year among both students and townspeople indicates that a warm welcome awaits the poet.

The Literary Society Tangle

The literary society controversy has become so befogged with grandiloquence, insinuations, personal spleen, talk of "dirty politics" and undisguised verbosity that the real issues have been lost sight of. Such methods cannot possibly do any good, and any real Willamette-spirited student ought to deem them wholly unworthy. Let us confine ourselves to facts and to essentials, and above all, if we have nothing constructive to offer, let us remain discreetly silent. The good name and interests of Willamette are of more moment than cheap babbling in personalities.

Here are some pertinent facts. A plan for pledging in men's literary societies was drawn up by the representatives of the four organizations and the plan was adopted by the Webstersians, the Lincolnians and the Philodorian, and rejected by the Chrestophillians. Taken as societies, the vote for the plan was 3 to 1; taken numerically, it was about 58 to not more than 30. And yet in the face of this overwhelming majority the Chrestophillians state that the plan is "definitely lost." What are their grounds for such a statement?

It is unfortunate that there is no organ of authority in the intersociety organization whereby a majority vote can be enforced. But such authority ought to be unnecessary in a school where democratic ideals are so thoroughly a part of the student life. Any body of students are obligated by all the sacred traditions of Willamette and by the principles of American democracy to abide by the will of the majority and the majority have spoken by a decisive vote. So I say that the plan is not and ought not to be lost.

The merits of the plan cannot be discussed in this limited space, but suffice it to be said, that it was de-

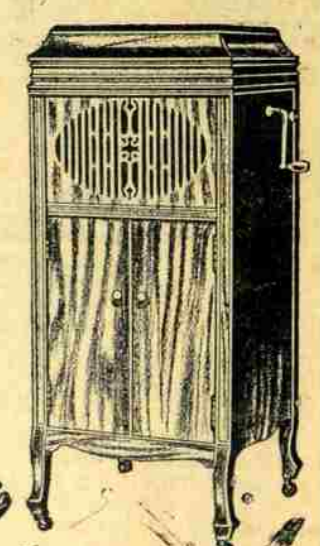

for A. S. B. finance and shall require bonds of whatever denominations it may deem appropriate from all persons having student funds in trust.

Clause 4. Uniform system bookkeeping. The executive committee shall establish a uniform system of bookkeeping throughout the departments of the association insofar as it is practicable, audit all accounts and file the same as permanent records.

Clause 5. Awards. The executive committee shall procure awards and choose the dates for award day.

Clause 6. Tryout for yell king and song queen. The executive committee shall arrange the tryout for yell king and song queen.

Clause 7. Elections. The executive committee shall arrange all elections as provided in Article IV of this constitution.

ARTICLE VII
Athletic Council

Section 1. Membership. The athletic council shall consist of:

- President of the A. S. B., who shall be presiding officer and shall vote only in case of a tie.
- Two alumni members to be chosen by the Alumni association.
- The president of the university.
- Two members at large from the A. S. B.

Section 2. Meetings. The athletic council shall hold four regular meetings during the year, the first, before October 15; the second, before the Northwest Intercollegiate conference; the third, before the opening of spring sports; the fourth, immediately before the close of the college year.

Clause 2. Special meetings. Special meetings may be called by the president of the A. S. B., where he deems it advisable, or upon the request of two members of the committee.

Clause 3. Quorum. A quorum shall consist of a majority of the members of the committee.

Section 3. Duties.

Clause 1. Athletic fund. The athletic council shall hold in trust, through the university office, a permanent athletic fund to be composed of 50 per cent of student body funds as provided in Article XIII, section 5, all money accruing from athletic contests or contracts, or from any other source.

Clause 2. Athletic budget. The athletic council shall make a budget of the funds granted to athletics by the executive committee specifying the amount for each separate branch of athletics.

Clause 3. Expenditure of funds. All bills over \$15 must be approved upon voucher by the athletic council and all bills under this amount must be approved by the athletic director. Checks must be signed by the business secretary of the university and the president of the A. S. B.

Clause 2. Athletic Budget. The Athletic Council shall make a budget for athletics specifying the amount for each separate branch of athletics.

Athletic Council shall make a budget for athletics specifying the amount for each separate branch of athletics.

Clause 3. Expenditure of funds. All bills over fifteen dollars (\$15) must be approved upon voucher by Athletic Council, and all bills under this amount must be approved by the athletic director. Checks must be signed by the Business Secretary of the University and the President of the A. S. B.

Clause 4. Athletic Director. The Athletic Director shall be administrative head of athletics, and as such shall schedule games, arrange contracts, select equipment, arrange for officials for all games and contests and supervise the work of athletic managers, in accordance with the policy which shall be outlined by the Athletic Council.

Clause 5. Athletic Manager. The Athletic Council shall appoint the following:

- A football manager.
- A baseball manager.
- A basketball manager.
- A track and tennis manager, and shall prescribe their respective duties.

Clause 6. General Powers. The Athletic Council shall have power to determine the general athletic policy of the school, shall approve all schedules of games, and shall choose and instruct the representatives of the university to the Northwest Inter-collegiate Conference.

ARTICLE VIII
Finance.

Section 1. Dues. The dues for membership in the association shall be five (\$5) dollars each semester,

payable at the time of registration. A signed note shall be considered as payment. Such payment shall entitle members to "Student Body Tickets" admitting them to all university games or contests held on the campus, and including them on the subscription list of The Willamette Collegian.

Section 2. Failure to Pay Dues. Failure or refusal to pay the Student Body dues shall make students ineligible to hold office in the association, vote at its elections, or represent it in any manner whatsoever.

Section 3. Funds. Student Body dues, together with all other money accrued by the association shall go into a general fund.

Section 4. Expenditure of Funds.

Clause 1. Support of Collegian. Fifty cents from each five dollars collected as dues shall go to the manager of The Willamette Collegian for the support of that paper.

Clause 2. Percentage of Funds to Athletics. Fifty per cent (50%) of the general fund shall be given to the support of athletics.

Clause 3. Expenditures not Athletic. All other expenditures shall be made by the Treasurer of the A. S. B., upon an official warrant.

Section 5. Class Taxes.

Clause 1. Collection of Taxes. A class tax of \$2.00 per semester shall be collected at the time of registration from each person who affiliates with any class.

Clause 2. Distribution of Class Taxes. The money so collected shall be distributed among the class treasurers by the Treasurer of the A. S. B., according to class affiliation as

indicated by the report of the registrar.

Clause 3. Additional Taxes. The collection of this tax shall not abridge the right of any class to levy additional taxes.

ARTICLE IX.
Treasurer.

Section 1. Qualification. The treasurer must give bonds as required by the Executive Committee before he shall receive funds belonging to this association.

Section 2. Duties. The duties of the Treasurer shall be as follows:

- Collect all dues and assessments and receive and hold in trust all money accruing to the association.
- Pay all approved bills and properly signed warrants.
- Keep an accurate account of all transactions; be ready upon five days' notice to render a full account to the Executive Committee or A. S. B., and make a complete report at the close of his term of office.
- Collect and disburse the class taxes as provided in Article VII.
- Order and issue student body tickets at time of registration.
