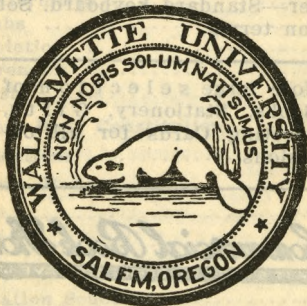

The Association is primarily a Christian organization. In order to carry out the purpose there are a number of departments which supervise various phases of activity.

The whole Association centers around the weekly meetings, which always carry inspiration and a deepened devotional spirit to those girls who attend. In addition there are the Bible study classes of unusual value given during the first semester.

Through other committees there is given a broader view of foreign students and of girls in industry.

Among the most attractive features of the Association is the work of the social committee which assists with the Y.M.-Y.W. reception and conducts the Jolly Jaunt and May Morning Breakfast.

Probably the most extensive department is the social service whose purpose is to bring greater joy to those who are less fortunate. The work deals particularly with children in the institutions around Salem. It also furnishes leaders for Girl Reserve groups in Salem high schools.

One of the finest experiences which can come into the life of any college girl is attendance at Seabeck conference, a ten-day camp held during the summer. There, in addition to inspiration from a perfect environment and to jolly fellowship with other girls, comes the widening vision of life brought by discussion and through splendid leadership. Every college girl should go to Seabeck.

The Y.W.C.A. also keeps the Association room on the second floor of Eaton Hall. It is for the comfort and use of every girl on the campus.

Though the Association is under the guidance of the cabinet, it exists for the girls of Willamette. It is desirous especially of creating that fine spirit of fellowship among the girls of Willamette which Christian love brings. It stands for all that is best at W. U. Through the Association it is hoped every girl may find an opportunity for the expression of Christian living.

The women's literary societies fill a place distinctively their own. The membership of the societies is carefully selected which permits a membership which is congenial and friendly. It is in the literary society that a girl develops her latent abilities, where her life is touched intimately by upper-classmen; where she finds relaxation from study hours; and where the social hour acquires a new significance. So often talents are hidden away in a napkin of self consciousness, the literary society helps to bring such talents from their seclusion. The programs have real literary merit and afford practice in appearing before audiences. Each society meets once each week for program, social hour and business meeting.

Women's Inter-Society Rules

Rule I. That each society shall hold its reception and each new woman shall have an opportunity to attend each society at least once, and not more than twice, before the second Saturday before Thanksgiving.

Rule II. That no woman shall be invited to join a society, either by verbal or written invitation, before the second Saturday before Thanksgiving.

Rule III. That each woman shall answer in writing.

Rule IV. That an inter-society council be established to consist of two members from each society to be appointed by the presidents of the respective societies at the last business meeting of the school year.

Rule V. That there shall be an additional member of the council, a faculty lady, elected by the council.

Rule VI. That the duty of the council shall be to decide all inter-society matters. Its decision shall be final.

Rule VII. That these rules shall be published in The Handbook and the first issue of the Collegian.

The following resolutions were clipped from the Collegian of June 6, 1923:

"We, the members of the Y.W.C.A. cabinet, feeling deeply the injustice and detrimental effects of the rush season of the past fall, hereby approve the following resolutions and submit them to the various women's literary societies for their consideration.

"1. In order to overcome the personal antagonism between societies and the barrier between the new students and the old, be it resolved that a feeling of friendliness and co-operation be maintained between societies by abolishing rules and attitudes on the part of society members which prevent personal friendships with new girls and the general spirit of friendliness for which Willamette stands. In order to prevent 'personal rushing,' be it resolved that the following pledge be personally signed by all society members:

"I hereby promise on my honor that in all contact with non-society girls, I will refrain from any discussion of my society or of any society. If this subject is introduced by a non-society girl I will simply tell her that I am honor-bound not to discuss this subject.

"2. Inasmuch as most of the hard feelings and disappointments of non-society girls arise from lack of understanding of society customs and conditions, be it resolved that more publicity be given to society matters, especially in regard to the number of vacancies in each society, such numbers to be stated in the first publication of the Collegian.

"3. In order to insure secrecy in the actual bidding, be it resolved that the preferential lists be prepared from the choice by the faculty member of the inter-society council alone and that these lists to be sealed and not opened until after the meeting in which they are to be voted upon has been formally opened.

"4. In order to overcome an excess of social engagements which defeat the

very purpose of our student life, be it resolved that only one rush day be allowed to each society outside of the regular at home and open meetings.

"We, being a group representative of all societies, desiring to uphold the high standards for which Willamette stands, present these aforestated resolutions requesting their adoption by the individual societies and by the inter-society council.

THE MEN'S LITERARY SOCIETIES

The men's literary societies are four in number. They are a very important cultural factor in the college life, affording a broad and necessary element of training which cannot be touched upon in the curriculum. The avowed purpose is to afford training in the preparation and presentation of papers, extemporaneous talks and debates, to coach in parliamentary procedure, and the proper handling of assemblies. The social activities have a large part in the life of each society and afford much wholesome training.

The societies are:

Philodorian, 1883—

The membership of these societies is chosen according to the following rules:

Men's Inter-Society Rules

Article I. The Inter-society committee.

Sec. 1. This committee shall be called the Men's Inter-society committee.

Sec. 2. This committee shall consist of

(a) One representative from each society selected at or before the first regular

meeting of the school year. He shall serve for the year unless absent from school, in which event his place shall be filled by the society.

(b) The presidents of the societies.

(c) If a permanent member of a society becomes president another member shall be selected for the interval.

Sec. 3. The committee shall be called together by the president of the Student Body before the first Saturday in October and shall choose a chairman from among its permanent members. The committee shall meet upon call of its chairman or of any three members thereafter.

Sec. 4. Six members shall constitute a quorum.

Sec. 5. Majority vote shall rule.

Article II. Jurisdiction.

Sec. 1. The committee shall have jurisdiction over all matters of inter-society interest.

Sec. 2. Each decision shall be binding on all of the societies unless rejected by one society.

Article III. Rules for rushing.

Sec. 1. Beginning with the second Wednesday after the completion of registration, each society shall hold four and only four open meetings to which one-fourth of all non-society men shall be invited. No one may be invited a second time to the same society.

Sec. 2. During this season, no society or members of a society shall participate in a social function or group in which a prospect is present if there are not present men from another society. This shall not apply to the programs mentioned in section 1 of this article. No direct or indirect bidding shall be carried on except as hereinafter specified. Unsportsmanlike conduct by any individual or society in the carrying out of these regulations shall make the society amenable to the Inter-society Committee.

Sec. 3. During the Friday afternoon following the fourth open meeting each society shall mail sealed invitations to the non-society men whom they wish to pledge. Acceptance must be mailed by Monday noon. From the mailing of the invitations until acceptances are due there shall be no communication whatever concerning societies between society and non-society men.

Sec. 4. There shall be no rules covering the acquiring of members for the remainder of the school year except that new men shall be encouraged to visit all societies before pledging.

Article IV.

Sec. 1. These rules may be amended at any meeting of the committee by a majority vote.

Sec. 2. All rules should be read to each society by permanent member on the committee at the following meeting after being passed by the committee. Rules shall be effective after the following regular meeting of each society unless rejected by one society.

Sec. 3. During the Friday afternoon following the fourth open meeting each society shall mail sealed invitations to the non-society men whom they wish to pledge. Acceptance must be mailed by Monday noon. From the mailing of the invitations until acceptance is due there shall be no communication whatever concerning societies between society and non-society men.

Sec. 4. There shall be no rules governing the securing of members for the remainder of the school year except that new

THE "W" CLUB

The "W" Club membership is composed of men and women who have received recognition for their participation in athletics in accordance with the provisions of the constitution concerning athletic awards. The organization takes a keen interest in Willamette and does much to further her interests athletically.

ATHLETICS

It may be said that Willamette enters the athletic field this year with renewed hope and bright prospects. Athletics have suffered much since the gymnasium burned but the new gym is bigger and better than our fondest dreams dared picture before we saw it taking shape.

Nor is the new gym her only hope. A new coach comes of whom there have been many praises written. There is no visible reason why Willamette should not write her name in athletic glory and only a pessimist forecasts unseen things.

The Athletic Council

Athletics at Willamette are controlled by an athletic council composed of faculty and alumni members, ex-officio members, and members at large from the student body. This council is one of the most important bodies on the campus, and its duties may be found in detail in the A.S.W.U. on page 41 of this publication.

Cubs

The Cubs are not necessarily athletic, but we think of them in connection with athletic events. The Cubs are the official retinue of the Yell King. Their duties are to greet visitors on the campus, maintain the campus spirit of friendliness, and assist generally at games and college festivals. They are known by their bright gold jerseys.

Women's Athletic Club

Women's athletics are expected to become an important W. U. activity now that an instructor and a gymnasium have been provided. The last few semesters have been disorganized but the women of the University are looking forward to a new epoch.

Girls' Willamette Club

The Girls' Willamette Club is made up of all the girls of the University. Its ideal is a better Willamette for the girls. It has one social function each year, the "Co-ed Carnival," which comes in April. This is strictly a woman's affair and no men attend.

FORENSICS

The Bar "W" Club

The Bar "W" Club is composed of people who have received recognition for their participation in forensics according to the provision of the A.S.W.U. constitution concerning forensic awards.

The gold bar "W" is a highly esteemed award and one to which many aspire but few attain, due to the large amount of work which precedes its winning.

The Forensic Council

The Forensic Council is composed of three wearers of the bar "W" and the coaches of debate. This council has charge of forensics in accordance with the provisions of the A.S.W.U. on page 47 of this publication.

Debate

Willamette has won many honors in debate. Last year her men's debate team traveled over a circuit which included Gustavus Adolphus College at St. Peter, Minn.; Laurence College at Appleton, Wis.; University of Arizona at Tuscon, Arizona; University of Redlands, Redlands, Calif.; and the College of the Pacific at San Jose, Calif. They suffered but one defeat on this trip. Two contracts were secured for the season of 1923-4 which promises as good a season of victories.

Women's Debate

The men's debate team is not the only exponent of debate at Willamette.

The women of the school participate, meeting women's teams from other schools. Their conquests have not been so numerous as the men's but they have valiently upheld the cardinal and the gold.

Oratory

Oratory is also an active activity at Willamette. During the past year there have been held several local contests and one state contest. The men who have represented Willamette have won worthy honors although they have failed to take first place.

MUSIC

The Ladies' Glee Club

The vacancies in the membership of this organization are filled by an open try-out. There is great interest in music at Willamette and the Ladies' Glee Club provides a pleasing expression of that interest. The club gave a series of local concerts, a home concert, and enjoyed a tour at mid-year which included many distant points.

The Men's Glee Club

This club is one of Willamette's prides. It is composed of the best male voices in the University and its membership is determined by open try-outs. The Dean of the School of Music is the director ex-officio. Each year this club tours Washington and Oregon carrying splendid musical programs to the large and the small towns alike. Besides affording the club great pleasure and good financial returns, it represents Willamette as an advertising feature.

The Varsity Band

The A.S.W.U. constitution provides encouragement for a Varsity Band in the provision of awards for activity in that field. Music furnished by a good band at athletic contests is a very great addition to the school spirit. It is hoped that in the coming years the Varsity Band will be as integral a part of college activities as athletics or forensics.

The Freshman Glee

This is an inter-class rivalry affair and is provided for in the A.S.W.U.

constitution. But it is also very much more. It is an occasion unique to Willamette. The songs produced are all of merit and are sung long afterward by the students. A college lives in its songs, and Freshman Glee guarantees long life to Willamette.

Cosmopolitan Club

The purpose of this club is "to furnish aid to foreign students to find work and to solve their peculiar problems; to interpret their life and engender a spirit of reciprocal understanding between the citizens of this country and their home countries. When opportunity affords these students will be sent out to discuss the problems of their people."

Washingtonian Club

This organization groups together those persons whose homes are in Washington state or have been at some other time. The banquet which the club sponsors on February twenty-second is an all college affair and one of the high points on the social calendar.

Discussion Club

This club is popularly known on the campus as the "Bolsheviks." Under the requested leadership of Professor Erickson these men meet to discuss current topics. The membership, although closed, is entirely unorganized. The club meets once each week at the noon hour.

The Lausanne Hall Club

The membership of this club is composed of those girls who live in Lausanne Hall. It has been said, "Lausanne

Hall is more than a building—it is an ideal.” The cultural advantages of living in such an environment are very marked and the investment of money in womanhood many times repaid.

The Student Volunteer Band

The Student Volunteer Band represents not an organization but a movement supported by students who are planning to enter into service in the foreign mission fields. The group holds weekly meetings for devotional study.

The Willamette Wesleyans

That little church hanging in Eaton Hall is the bulletin board that forecasts the programs of the Willamette Wesleyans. The Wesleyans organized two years ago to promote the interests of students who are looking toward Christian work in the home field. The organization has successfully supplied a genuine need for a helpful union of such young people. The members lunch together each Wednesday noon and discuss questions related to their field.

The Missionary Committee

The Missionary Committee is made up of nine members. Three members are chosen from the Student Volunteer Band, three from the Y.M.C.A., and three from the Y.W.C.A. It is through this committee that single appeal is made for all the benevolent causes that come before the students during the year. To arouse an interest in missionary enterprise the committee will enlist all of those already interested into various groups, each of which will prepare and deliver a report upon some mission field. If you would hear the

voice of this committee, watch the large bulletin board in Eaton Hall.

Honor Code Committee

Student honor has long been a tradition at Willamette in that it was the accepted attitude of the students. As the student body increased in numbers and in types of personalities it became necessary that the honor tradition be embodied in a code. Much time and effort were expended before the present code was adopted. The Honor Code Committee is in charge of the enforcement of the honor code. Each Willamette student will acquaint himself with the spirit and provisions of the code which may be found in the A.S. W.U. constitution on page 58 of this publication.

The Missionary Committee

The Missionary Committee is made up of nine members. Three members are chosen from the Student Volunteer Band, three from the Y.M.C.A. and three from the Y.W.C.A. It is through this committee that single appeal is made for all the benevolent causes that come before the student body.

**THE CONSTITUTION
of the
ASSOCIATED STUDENTS
of
WILLAMETTE UNIVERSITY**

Preamble

We, the students of Willamette University, in order to provide an organization for the control of all matters of general student concern, do hereby ordain and establish the following constitution and by-laws.

Constitution

Article I—Organization

Section 1. Name. The name of this organization shall be the Associated Students of Willamette University.

Sec. 2. Membership. All registered students in the departments of Willamette University shall be active members of the Associated Students of Willamette University upon payment of the student body fee, as provided in Article VIII of this constitution.

Article II—Meetings

Sec. 1. Regular. The regular meetings of the Associated Students of Willamette University shall be held on the third Friday of each month during the school year.

Sec. 2. Special. Special meetings shall be held upon the call of the president on his own initiative, upon request of three members of the executive committee, or upon a petition of fifty members; provided that twenty-four hours notice shall have been given in all departments before such meetings.

Sec. 3. Quorum. Fifty per cent of the members shall constitute a quorum.

Article III—Officers

Sec. 1. General officers. The officers of this organization shall be president, vice-president, secretary, and treasurer, all of whom shall be chosen from the two upper classes of the following year.

Sec. 2. Duties of president. The president shall preside at all meetings of the association; shall be ex-officio chairman of the executive committee and the athletic council; shall appoint such committees as are hereinafter specified; shall approve all bills in writing and sign all warrants for disbursement of funds except as provided in Article VII of this constitution; and shall perform the usual duties appertaining to this office.

Sec. 3. Duties of vice-president. The vice-president shall assume the duties of president in the absence of that officer.

Sec. 4. Duties of secretary. The secretary shall keep records of all proceedings of this association and at the close of the college year shall place the above records in the care of the registrar of the University.

Sec. 5. Duties of treasurer. The duties of the treasurer shall be as outlined in Article IX of this constitution.

Article IV—Elections

Sec. 1. Officers elected at regular election. The president, vice-president, secretary, editor of the Collegian, and the four student members of the athletic council shall be elected at the regular election to be held the fourth Friday in April.

Sec. 2. Nomination. Nomination for the officers named in Section 1 shall be made by petition, signed by twenty-five members. Said petition shall be filed with the executive committee before the Saturday preceding election, and must be sanctioned in writing by the nominee. Said petition shall be posted on the A.S.W.U. bulletin boards by the executive committee by the Saturday preceding election, and the names of the candidates shall be published in the Willamette Collegian previous to the election. The privilege to write in the names of candidates on the ballots shall not be abridged by this provision.

Sec. 3. Rules for election. The provisions of this section shall be effective in the election of the officers listed in Section 1.

Clause 1. The Australian system. The Australian ballot system shall be used.

Clause 2. The polls shall be open from 10 a. m. to 4 p. m. and for the law department at such times and such a place as shall be deemed expedient by the executive committee, providing that public notice of such time and place shall be given one week previous to balloting.

Clause 3. Election officers. There shall be at the polls at all times an inspector, one ballot distributor, and one clerk.

Clause 4. Ballots. The ballot distributor shall give out one ballot to each voter, and ballots shall not be received from any other source.

Clause 5. Eligibility to vote. The clerk shall keep an official poll-book compiled by the treasurer as provided in Article IX of this constitution and no one shall be permitted to vote whose name is not listed in this book.

Clause 6. Counting ballots. The ballots shall be counted by the executive committee, or a special committee provided by the executive committee, immediately after the closing of the polls, and the result of the election shall be posted on the various department bulletin boards.

Clause 7. Electioneering. No electioneering nor soliciting of votes shall be permitted within limits established around the polls by the inspector.

Clause 8. Majority. It shall require a majority vote to elect, and in case no candidate receives such a majority the executive committee shall call a new election within one week; at this election only the names of the two candidates receiving the highest number of votes shall appear on the ballot.

Sec. 4. Term of office. The officers listed in Section 1 shall assume the duties of their respective offices at the beginning of the college year following their election, and shall hold office one year or until their successors shall be regularly elected and qualified.

Sec. 5. Installation. Formal installation of these officers shall be held at the last regular meeting of each college year.

Sec. 6. Special elections. Special elections shall be held as follows:

Clause 1. At the first regular meeting of the association each year the following officers shall be chosen by ballot:

A. The four members at large of the executive committee; one from each of the four classes.

B. The faculty member of the executive committee.

C. An inter-class rivalry chairman. It shall require a majority to elect.

Clause 2. At the regular meeting of the association in March nominations for May Queen shall be made from among the girls of the senior class by popular ballot of the A.S.W.U. The three girls receiving the highest number of votes shall become candidates for this office. Election shall be held one week after nomination, and a plurality shall elect.

Clause 3. Nominations for the forensic council shall be made at the regular May meeting of the association. The election shall be held the following Wednesday.

Clause 4. At any regular or special meeting of the association a special election may be called to fill any vacancy that may occur in any elective office.

Section 7. Recall. A special election for the recall of any officer or officers of the association shall be called by the president of the A.S.W.U. at the petition of twenty-five per cent (25%) of the members. It shall require a two-thirds ($\frac{2}{3}$) vote to effect the recall.

Article V—Vacancies

All vacancies which may occur in elective offices shall be filled by the regular popular ballot at the special election.

Article VI—Executive Committee

Sec. 1. Membership. The executive committee shall consist of:

A.—President of the A.S.W.U., who shall be the presiding officer without vote except in case of tie.

B.—Vice-president of the A.S.W.U.

C.—Secretary of the A.S.W.U., who shall keep a complete record of the proceedings of the committee.

D.—The treasurer of the A.S.W.U.

E.—A member of the faculty of the College of Liberal Arts.

F.—Editor of the Collegian.

G.—Four members at large from the A.S.W.U., one from each of the four classes.

Sec. 2. Meetings.

Clause 1. Regular. Regular meetings of the executive committee shall be held once in each fortnight during the college year.

Clause 2. Special. Special meetings shall be held upon the call of the president or the request of three members of the committee.

Clause 3. Quorum. Five members besides the presiding officer shall constitute a quorum.

Sec. 3. Duties.

Clause 1. Make the following appointments:

A.—Collegian manager for the following year before May 15.

B.—May day manager before March 1.

C.—A Yell King, a Crown Prince, and a Song Queen before May 15.

Clause 2. Enforce constitution. The executive committee shall require all officers to comply with the provisions of the constitution and shall have full control over all student activities not otherwise delegated.

Clause 3. Prepare budget and require bonds. The executive committee shall prepare a general budget for the

A.S.W.U. finances and shall require bonds of whatever denominations it may deem appropriate from all persons having student funds in trust.

Clause 4. Uniform system of book-keeping. The executive committee shall establish a uniform system of bookkeeping throughout the departments of the association in so far as it is practicable, audit all accounts, and file the same as permanent records.

Clause 5. Awards. The executive committee shall procure awards as ordered by the awards committee.

Clause 6. Elections. The executive committee shall arrange all elections as provided in Article IV in this constitution.

Article VII—Athletic Council

Sec. 1. Membership. The athletic council shall consist of:

A.—President of the A.S.W.U. who shall be presiding officer and shall vote only in case of a tie.

B.—Two alumni members to be chosen by the alumni association.

C.—The president of the University.

D.—The faculty member of the executive committee.

E.—Four members at large from the A.S.W.U., one of whom shall be a woman

F.—The athletic director, without vote.

Sec. 2. Meetings.

Clause 1. Regular meetings. The athletic council shall hold four regular meetings during the year, the first, before October 15; the second, before January 15, at which the athletic direc-

tor shall not be present; the third, before the opening of spring sports; the fourth, immediately before the close of the college year.

Clause 2. Special meetings. Special meetings may be called at the request of the athletic director or of two members of the council.

Clause 3. Quorum. A quorum shall consist of a majority of the members of the council.

Sec. 3. Duties.

Clause 1. Athletic fund. The athletic council shall hold in trust, through the University office, a permanent athletic fund to be composed of fifty per cent of student body funds as provided in Article VII, Section 4, and all moneys accruing from athletic contests, or contracts, or from any other source.

Clause 2. Athletic budget. The athletic council shall make a budget of the funds granted to athletics by the executive committee, specifying the amount for each separate branch of athletics.

Clause 3. Expenditure of funds. All bills over \$15 must be approved upon voucher by the athletic council and all bills under this amount must be approved by the athletic director. Checks must be signed by the business secretary of the University and the president of the A.S.W.U.

Clause 4. Athletic director. The athletic director shall be the administrative head of athletics, and as such shall schedule games, arrange contracts, select equipment, arrange for officials for all games and contests, and supervise the work of athletic managers, in accordance with the poli-

cy which shall be outlined by the athletic council.

Clause 5. Athletic managers. The athletic council shall appoint the following:

A.—A football manager.

B.—A basketball manager.

C.—A baseball manager.

D.—A track and tennis manager, and shall prescribe their respective duties.

Clause 6. The athletic council shall determine the general athletic policy of the school, approve all schedules of games, choose and instruct the representatives of the University to the Northwest Inter-collegiate Conference, and recommend to the president of the University, each year before January 15, an athletic director.

Article VIII—Dues

Sec. 1. A.S.W.U.

Clause 1. The dues for membership in this association shall be five dollars (\$5.00) each semester, payable at the time of registration. A signed note shall be considered as payment. Such payment shall entitle members to "Student Body tickets," admitting them to all University games or contests held on the campus, and including them on the subscription list of the Willamette Collegian.

Clause 2. Failure to pay dues. Failure or refusal to pay student body dues shall make students ineligible to hold office in the association, vote at its elections, or represent it in any manner whatsoever.

Clause 3. Funds. Student body dues, together with all other moneys accrued by the association shall go into a general fund.

Clause 4. Expenditure of funds.

Division 1. Ten per cent of the general fund shall go to the manager of the Willamette Collegian for the support of that paper.

Division 2. Percentage of funds to athletics. Fifty per cent of the general fund shall be given to the support of athletics.

Division 3. Expenditure not athletic. All other expenditures shall be made by the treasurer of the A.S.W.U. upon an official warrant.

Sec. 2. Class.

Clause 1. Collection of taxes. A class tax of two dollars per semester shall be collected at the time of registration from each person who affiliates with any class.

Clause 2. Distribution of class taxes. The money so collected shall be distributed among the class treasurers by the treasurer of the A.S.W.U. according to class affiliation of those who pay as indicated by the report of the registrar.

Clause 3. Additional taxes. The collection of this tax shall not abridge the right of any class to levy additional taxes.

Article IX—Treasurer

Sec. 1. Qualification. The treasurer must give bonds as required by the executive committee before he shall receive funds belonging to this association.

Sec. 2. Duties. The duties of the treasurer shall be as follows:

A.—Collect all dues and assessments and receive and hold in trust all moneys accruing to this association.

B.—Pay all approved bills and properly signed warrants.

C.—Keep an accurate account of all transactions; be ready upon five days notice to render a full account to the executive committee of the A.S.W.U., and make a complete report at the close of his term of office.

D.—Collect and disburse the class taxes as provided in Article VIII.

E.—Order and issue student body tickets at the time of registration.

F.—Provide official poll books for all A.S.W.U. elections by listing the names of all students who have paid their dues one week before the time of elections

Article X—Willamette Collegian

Sec. 1. The paper shall be known as the Willamette Collegian.

Sec. 2. The active policy of the paper shall be determined by the editor and manager, each of whom shall organize his staff.

Sec. 3. The president of the A.S.W.U. shall appoint a committee of three to draw up a contract for the student body, party of the first part, the business manager and editor of the Collegian, party of the second part, said contract to contain specifications for a minimum number of thirty issues per year on a weekly basis, and any other points required by the executive committee. This contract shall be signed before the publication of the first issue.

Sec. 4. The manager shall render to the executive committee a monthly report of the financial status of the paper.

Sec. 5. At the end of the college

year all profits shall be divided as follows:

A.—An amount equal to ten per cent of the funds received from the A.S.W.U. shall be placed in a permanent Collegian fund.

B.—Further profits to the amount of two hundred dollars shall be divided equally between the editor and manager.

C.—Of all other profits twenty-five per cent shall be paid to the manager and the remaining seventy-five per cent shall go into the permanent Collegian fund.

Sec. 6. The permanent Collegian fund, which shall be administered by the executive committee, may be appropriated only to cover deficits in current expenses of the Collegian and to pay for permanent improvements advisable by the executive committee.

Article XI—Forensic Council

Sec. 1. The forensic council shall consist of:

A.—Three Bar "W" members of the A.S.W.U., one of whom shall be a man and one of whom shall be a woman.

B.—Coaches of debate.

Sec. 2. Election for the forensic council shall be held on the Wednesday following the regular May meeting of the A.S.W.U.

Sec. 3. The president of the A.S.W.U. shall call a meeting of the council within ten days following its election. The council shall at this meeting choose a chairman from its members.

Sec. 4. The chairman of the council shall have direct charge of all debate

and oratorical activities and be responsible for all moneys within the forensic department, but shall be held accountable by the council in the fulfillment of his duties.

Sec. 5. The chairman shall nominate to the council as he shall see fit any other persons to be officially connected with these activities.

Article XII—Yell King and Song Queen

Sec. 1. Officers. The officers of this department shall be Yell King, Crown Prince, and Song Queen.

Sec. 2. They shall be selected by the executive committee.

Sec. 3. Term of office. The term of office of these officers shall be the same as that of other A.S.W.U. officers.

Sec. 4. Duties.

Clause 1. Yell King. It shall be the duty of the Yell King to endeavor at all times to promote loyalty to Willamette University and enthusiasm over its student activities. For this end he shall, during his term of office,

A.—Provide for and conduct at least two rallies of an athletic nature and one of forensic nature;

B.—Personally conduct the rooting at two-thirds of the inter-collegiate contests held at home, and provide for the other one-third;

C.—Provide decorations for the grandstand at all field contests and provide a band whenever possible;

D.—Have charge of all excursions accompanying teams to other colleges.

Clause 2. Crown Prince. It shall be the duty of the Crown Prince to assist in the leading of yells at rallies and contests, and in otherwise promoting

interest and enthusiasm in student activities.

Clause 3. Song Queen. It shall be the duty of the Song Queen to lead in the singing at all rallies and contests.

Article XIII—May Day

Sec. 1. The A.S.W.U. shall hold an annual May Day Festival on the first Friday of May.

Sec. 2. The Festival shall be conducted by a committee of four, composed of a manager appointed by the executive committee, who shall be chairman, and three assistants appointed by the president of the A.S.W.U.

Sec. 3. There shall be a Queen of May elected according to Article IV of this constitution.

Article XIV—Clubs

Sec. 1. Athletic "W" Club.

Clause 1. The name of this organization shall be the "W" Club.

Clause 2. Membership. All wearers of the official athletic "W" shall be members of this club.

Clause 3. Organization. This organization shall have power to elect its own officers and maintain an independent existence in so far as this does not conflict with the provisions of this constitution.

Sec. 2. Forensic "W" Club.

Clause 1. The name of this organization shall be the Bar "W" Club.

Clause 2. All wearers of the official Bar "W" shall be members of this club.

Clause 3. Organization. This organization shall have power to elect its own officers and maintain an independent existence in so far as this does

not conflict with the provisions of this constitution.

Sec. 3. Girls' Willamette Club.

Clause 1. Name. The name of this organization shall be the Girls' Willamette Club.

Clause 2. Membership. All the girls of the A.S.W.U. shall be members of this organization.

Clause 3. Organization. The Girls' Willamette Club shall elect its own officers and maintain an independent existence in so far as this does not conflict with the provisions of this constitution.

Article XV—Special Committees

Sec. 1. Auditing committee. There shall be an auditing committee composed of the vice-president of the A.S.W.U. and two others appointed by the president of the A.S.W.U. which shall audit the books of the treasurer of the A.S.W.U.

Sec. 2. Freshman Glee committee. There shall be a Freshman Glee committee of four as provided in Article III of the by-laws.

Sec. 3. May Day committee. There shall be a May Day committee of four as provided in Article XIII of this constitution.

Sec. 4. Inter-class Rivalry committee. There shall be an Inter-class Rivalry committee as provided in Article IV of the by-laws.

Sec. 5. Honor Code committee. There shall be an Honor Code committee of seven appointed by the executive committee of the A.S.W.U. as provided in Article V of the by-laws.

Sec. 6. Awards committee. There shall be an Awards committee as provided in Article II of the by-laws.

Article XVI

Any act of any officer, committee, or organization existing under this constitution may be repealed or amended by a two-thirds vote at any regular or special meeting of this organization.

Article XVII—Amendments

Amendments to this constitution may be proposed in writing at any meeting of this association. They shall then be posted for at least ten days and must appear in the Willamette Collegian. At any subsequent meeting they may be passed, provided that they receive a two-thirds vote.

BY-LAWS

Article I—Order of Business

Sec. 1. The order of business shall be:

Reading of minutes

Reports of committees

Unfinished business

New business

Adjournment.

Sec. 2. Rules of order. Roberts' Rules of Order shall be the standard of parliamentary procedure.

Article II—Awards

Sec. 1. Awards committee.

Clause 1. The Awards committee shall consist of the president of the A.S.W.U., who shall be chairman; the secretary of the A.S.W.U., who shall keep a record of all proceedings; the faculty member of the executive committee, and:

For athletic awards, the coach and manager of the activity involved;

For forensic awards, the coach of the activity and the chairman of the forensic council;

For Collegian awards, the editor and the assistant editors;

For the band, the Yell King and the director.

Clause 2. Four members shall constitute a quorum.

Sec. 2. Athletics.

Clause 2. The official award for participation in football, basketball, track, and tennis shall be a cardinal sweater

(V or roll-neck, optional) bearing on the chest an old gold, full block "W" $7\frac{1}{2}$ inches high by $8\frac{3}{4}$ inches wide by $1\frac{1}{2}$ inches.

Clause 2. Awards shall be given as follows:

Division 1. Football—to men playing five complete quarters of conference football.

Division 2. Basketball—to men playing five conference games or the equivalent playing time.

Division 3. Baseball—to men playing two-thirds of the total innings, except pitchers, who shall play one-fourth of the total innings.

Division 4. Track.

A.—To men making three points in a meet with a conference team in which freshmen are not eligible.

B.—To men making six points in a meet with a conference team in which freshmen are eligible.

C.—To men placing in the Northwest Conference meet.

D.—To men earning the total of twenty points in all meets of the season.

E.—Each member of a relay team which wins first place shall receive two points.

Division 5. Tennis—to men winning a match with a team of conference standing or playing in at least three conference meets.

Clause 3. Four-year awards. Any member of a varsity athletic team who has earned the official award for three years and turned out for four years in either football, basketball, baseball, track, or tennis shall be en-

titled to the official cardinal Indian blanket, which shall be 56 inches by 80 inches in dimensions with an old gold block "W" 2 by 12 by 14 inches, sewed in the center. The blanket shall weigh at least three pounds. Five pointed stars, the points resting on a circle three inches in diameter, shall be used to designate in what sport awards have been earned. Each star shall represent a season's service. The stars shall be arranged as follows: For football and basketball the stars shall be placed in parallel lines above the letter, the first line being three inches from the letter tips, the second two inches above the first. The stars in line shall be three inches apart. Stars arranged as above noted shall be placed below the letter for baseball and track. For football the stars shall be old gold; for basketball, black; for baseball, green; for track, blue; for tennis, silver. For each season's captaincy a ring three and one-half inches in diameter shall surround the star; and it shall be the same color as the star. Any individual shall be entitled to only one official blanket.

Clause 4. Each of the four athletic managers shall receive a cardinal sweater with two side pockets and a block old gold "W" four inches by three inches on the left pocket.

Clause 5. No official award to anyone below sophomore standing in the University shall include a sweater, but freshmen shall receive the official certificate and letter on the first award day after earning the same and such individuals shall receive the sweater on the first award day following his registration after receiving sophomore rating.

Sec. 3. Forensics.

Clause 1. Official award for participation in forensics shall be a solid gold block "W" $\frac{3}{8}$ of an inch wide, mounted on a gold bar $\frac{5}{8}$ of an inch long.

Clause 2. Awards shall be given as follows:

Division 1. Debate—winning of one or participation in two inter-collegiate debates.

Division 2. Oratory—participation in an inter-collegiate contest in which at least five colleges participate.

Sec. 4. Band.

Clause 1. Official award for participation in the band shall be a solid gold lyre designed as a "W," which shall be $\frac{5}{8}$ of an inch high by $\frac{3}{8}$ of an inch wide.

Clause 2. Award shall be given to students for complete participation in three-fourths of the local appearances; provided that the band shall appear at all local football and basketball games, and provided that the band at such appearances shall have all the pieces of a ten-piece regulation band.

Clause 3. The earning of four awards shall entitle the member to a cardinal felt pillow top bearing an old gold "W" of the design of the pin award.

Sec. 5. Yell King. The award of the Yell King shall be the official sweater with a round old gold "WU" which shall be on the left of the chest.

Sec. 6. Collegian.

Clause 1. Collegian award shall be a solid gold old English "C."

Clause 2. Faithful and punctual service of high quality shall entitle a member of the Collegian staff to the official award; provided that not more than forty per cent of any year's staff shall receive such award.

Sec. 7. Any person failing to finish the season with the respective group and the semester in school shall forfeit the award except in the event of unavoidable incapacitation, which is to be determined by the awards committee.

Sec. 8. No person shall receive more than one award in athletics, or in forensics, or for Collegian service, or for participation in the band, or for Yell King, or for manager of athletics. For each award earned he shall receive a certificate specifying the fact. This certificate shall be proof of the right to wear such award.

Sec. 9. Each graduate who has received an award based upon inter-collegiate activities shall be awarded on the last award day previous to graduation a parchment four inches by five inches, on which shall be a record of the awards earned in inter-collegiate activities.

Sec. 10. There shall be three award days. The first shall follow the football season as early as is practical. The second shall follow the basketball season as early as is practical. The third shall be late in May at which time all A.S.W.U. awards shall be presented. The exact dates shall be set by the awards committee for which purpose it shall be composed of all officers concerned which were enumerated in Section 1 of this article. The president of the A.S.W.U. shall be responsible for the presentation of awards.

Article III—Freshman Glee

Sec. 1. An inter-class song contest called the Freshman Glee shall be held annually on the second Saturday in March. The glee shall result from a challenge by the freshman class to the other classes given at least six weeks previously.

4 Sec. 2. The glee shall be conducted by a manager elected by the freshman class, who shall act under the supervision of a committee of three upper-classmen appointed by the president of the A.S.W.U., one of whom shall be designated as chairman. The four shall constitute the Freshman Glee committee.

Sec. 3. Words and music shall be composed within the class rendering the song and the song shall be rendered by the entire class.

Sec. 4. There shall be three judges on each of words, music, rendition, and adaptation. They shall be selected by the Freshman Glee committee and shall judge according to rules laid down by that committee.

Sec. 5. The freshmen shall present the winning class with the permanent Freshman Glee pennant upon which shall be pinned in the proper place a sterling silver pin which shall not be larger than $1\frac{3}{4}$ inches by $1\frac{1}{4}$ inches.

Sec. 6. The Freshman Glee committee shall decide before the regular A.S.W.U. meeting in May the type of song for the ensuing year. The type selected shall be published in the last and first issues of the Collegian for the year and announced at the last and first meetings of the A.S.W.U. of the year.

Article IV—Inter-class Rivalry

Sec. 1. Inter-class Rivalry committee.

Clause 1. There shall be an Inter-class rivalry committee elected each year, consisting of the following members: a chairman elected by the A.S.W.U. and one member elected by each of the classes.

Clause 2. The chairman of the committee shall be an upperclassman and shall be elected at the first regular meeting of the A.S.W.U. for the year. The representatives of the classes shall be elected within the first two weeks of the school year.

Sec. 2. Duties.

Clause 1. The committee shall regulate and control all forms of inter-class rivalry including numeral painting and inter-class disputes.

Clause 2. The following inter-class activities shall be held each year: basketball, tennis, baseball, forensics, Freshman Glee, and other activities that the committee shall decide upon. Percentage of class membership earning inter-collegiate awards for the year shall be counted an activity. In all activities first place shall receive five points, the second place three points, and the third place one point.

Sec. 3. Contestants.

Clause 1. Representatives of the classes must rate: for the seniors 88 credits, for the juniors 56, for the sophomores 24. Students carrying less than twelve hours shall not be eligible, provided that seniors carrying sufficient hours for graduation shall be eligible.

Clause 2. The class having the highest number of points at the close of the year shall be the inter-class rivalry champion and shall receive a suitable award.

Article V—Willamette's Honor Code

Sec. 1. Code. For the purpose of perpetuating the spirit and practice of honor which Willamette University has always cherished as her ideal, the A.S.W.U. hereby adopts the following standard of action to be considered as its tradition of honor. Dishonesty in examination, unfair work on notebooks and essays, improper use of library books and materials as well as property of other persons, and the employment of all illegitimate methods not herein specified, shall be deemed opposed to Willamette's standard; and students guilty of such action shall be guilty of flagrant violation of the sacred traditions of the University.

Sec. 2. Enforcement.

Clause 1. Enforcement of this code shall be under the direct supervision of the executive committee, which shall appoint at its first meeting in October seven students, four of whom shall be seniors, two juniors, and one a sophomore. These shall constitute the Honor Code committee. The committee shall be called together by the president of the A.S.W.U. within seven days, at which time one of the committee shall be elected as chairman. The committee shall organize further as it sees fit.

Clause 2. The Honor Code committee shall have charge of the enforcement of the Honor Code.

Clause 3. The executive committee may grant an appeal to the A.S.W.U.

Clause 4. All decisions shall be subject to review by the president of the University.

Article VI—Amendments.

Amendments to these by-laws must have been read at a previous meeting, must have been posted for ten days, and must have been published in the Willamette Collegian before coming up for adoption at a regular meeting of the A.S.W.U. They must receive a two-thirds vote for adoption.

PRIZES

Keyes Prizes—Hon. Walter E. Keyes of Salem offers two prizes of \$15 and \$10 to those who win first and second honors in oratory.

Steeves Prize—A prize of \$10 offered by Dr. B. L. Steeves, '91, for the student who does the best work in Latin.

University Prizes—The University offers the following prizes to winners in any University contest in public speaking, to be applied in the College of Liberal Arts, except when won by seniors in their last semester.

1. Five dollars to the winner in their last semester.

2. Ten dollars to the winner in an inter-collegiate contest.

3. Fifteen dollars to the winner in an inter-state contest.

No person may receive more than one prize in any college year.

(A winning team in debate will divide the University prize.)

Albert Prize—Mr. Jos. H. Albert of Salem, awards \$25 to the student having a record for faithful study and a scholarship not below the average, who, during the school year, opportunities considered, has made the greatest progress toward the ideal in (1) Character, (2) Service, and (3) Wholesome Influence. The award will be made in the following manner: The faculty, thirty days before commencement, shall nominate three students for the

honor and the student body two weeks before commencement shall select one of the three by secret ballot. No person may receive this prize more than once.

Alpha Kappa Nu—Not more than twenty per cent of any senior class are eligible to election in this honorary scholarship society. Elections are made by the faculty on the basis of scholarship and character, in May preceding graduation.

Senior Scholars—Senior scholars are chosen from the various departments each year to serve as readers and student assistants in the respective departments. Besides the honor attached to the choice there is also credit given in college hours.

The Colonel Willis Prize—Col. Percy Willis, '85, of Portland, offers a prize of \$25 "to the student who throughout the school year has done the most real good to fellow students and the University by deeds of kindness and genuine helpfulness, coupled with steadfast devotion to high ideals and upright character."

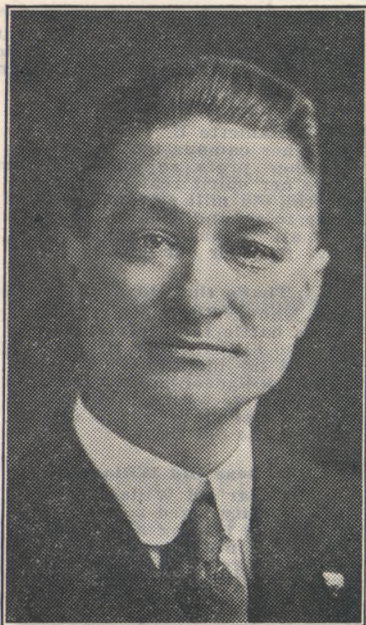

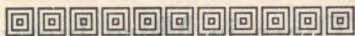

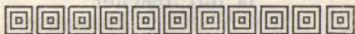
