

WU Debaters Earn NY Bid Editor Ryan Plans Color For Wallulah

A Willamette University debate team has received one of the highest of forensic honors, the right to represent the Pacific Northwest in the annual Invitational Debate Tournament at West Point, New York. The announcement was made this week by Dr. Howard W. Run-

kel, coach of forensics at Willamette.

Two other teams from this part of the country, University of Oregon and Idaho State College, will join the Willamette team for the April 26-29 event at the United States Military Academy.

The Willamette speakers winning the honor are Lynn Hales and Charles Bush. The two men have participated in a variety of speech events and tournaments during their years at Willamette.

This year they have won 20 and lost 6 debates. In two intercollegiate

tournaments, those held at the Pacific Lutheran University and at the University of Puget Sound, Hales and Bush were undefeated in a total of 12 contests. Among the universities over whom they gained wins were Hawaii, the University of Southern California and the University of Washington.

Hales has won honors in extemporaneous and impromptu speaking events. Bush has taken prizes in impromptu speaking, oratory and interpretive reading.

The two men and their coach, Dr. Howard W. Runkel, will fly to New York late in April to join the top-ranked teams from the other seven forensic districts of the United States designated to participate in the invitational tournament.

Editor Ryan Plans Color For Wallulah

John Ryan, a sophomore, has been elected Wallulah editor for 1961-62. Among his plans and hopes for next year's yearbook include more color, less formality and a portrayal of "college life as it really is."

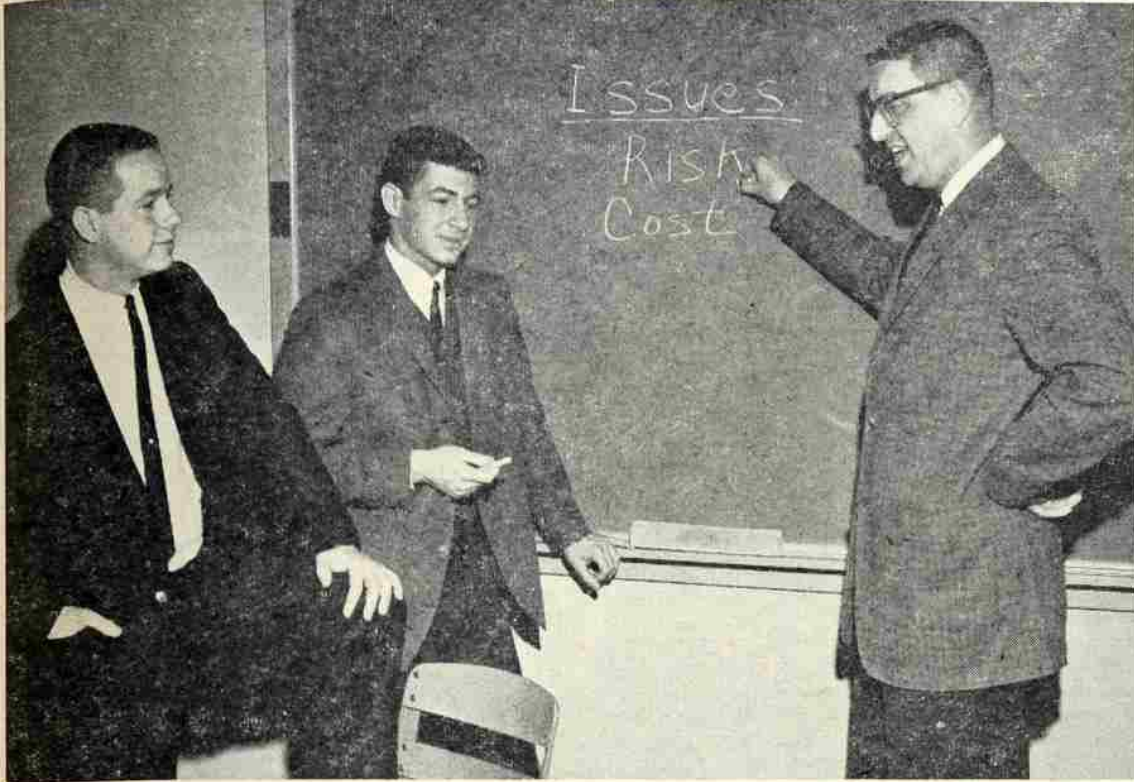

Our suggestions are as follows:

1—Not more than 250 words in length.
2—Valid signature, printed with the letter unless special circumstances are explained to the satisfaction of the editor. Any letter submitted with a great number of signatures may be printed with only a few signatures. A file of complete signatures in such cases will be available for inspection in the *Collegian* office. Anyone wishing to submit a letter with more than six signees should consult with the editor.

3—Submitted to the *Collegian* no later than 7 p. m. on Tuesday night. Letters may be left in the *Collegian* mailbox in Eaton or be given to any member of the *Collegian* staff.

Athletes Join Verbal Fray

DEAR EDITOR:

It is quite obvious from the article appearing in the February 17 issue of the *Collegian* that Paul deLespinasse feels very strongly about abolishing inter-collegiate sports. He presented some typical views of a person who has not participated in athletics. If I may, I would like to present what might be termed the "athletic" side, because by participating I have come to realize that there are many advantages to be derived.

BEFORE GOING into the advantages of athletics, I would first like to comment on the previous article. If Mr. deLespinasse is speaking against athletics as having a place in college, then perhaps the physical fitness programs advocated by Dwight Eisenhower and President John Kennedy, based on much research, are not valid. College athletics is just one of the areas that can support this program.

By taking away athletics you would be penalizing those who desire to participate and those who enjoy watching for the vicarious enjoyment they derive. If a person could not see fit to "lower" himself to watch Willamette participate against some other school, then he wouldn't have to attend any of the games. It is as simple as that.

BUT FOR those who do come to the games . . . and perhaps Mr. deLespinasse forgot that football attendance this year was higher than it has ever been . . . they certainly shouldn't be denied the privilege of enjoying the thrills that athletics has to offer. Of course, if a person has not afforded himself the chance to enjoy sports, then he wouldn't realize too much what they have to offer.

I'm not saying that Mr. deLespinasse doesn't have some valid arguments based on his values, and that is what the whole issue appears to be, a matter of values and interests. I don't feel that by continuing the athletic program as it is, it would hurt those who don't care for it.

THERE SEEMED to be some implication in his stand about the intellectual validity of athletics. The Willamette football team averaged 2.7 for the first semester, equal to the all-school average. In light of the fact that football practice takes a good three hours of practice a day, it would appear that those "who should not have been admitted to a University" have done a pretty good job academically as well as bringing home the championship.

As to the values of athletics as I have found them. They are a fine source of everlasting friendships, teamwork, of physical fitness, competition, discipline, acknowledgment, satisfaction, enjoyment for the athlete as well as the observer and many other intangible things. I don't think that there is any question that athletics do have an important place in our society. I realize that this argument could be used for a combination of other activities, but I don't believe these values can be found in any one other thing.

Certainly athletics enjoy public acclaim . . . look at hockey in Portland . . . so I really don't think that as long as a group of people favors something that can be avoided by those who haven't had the pleasure of participating, either directly or vicariously, then there is no need to do away with it. That is why I don't believe an answer was submitted sooner, as not enough people took Mr. deLespinasse's article seriously.

A loss at the gate does not mean we should abandon athletics any more than the fact that your tuition not covering all of your costs here means we should drop you.

This is in reply to the recent attacks on inter-collegiate athletics at Willamette by Paul deLespinasse. I would like to address the content of this letter to him.

YOU SEEM very well-informed on the athletic situation here at Willamette. For instance, referring to your statement that it "costs each student \$25 per year." First of all your figure is wrong. On an average basis, it is \$10, but secondly, your basic reasoning is wrong.

The tone of your letter implies that this \$25 is taken from tuition. This is not so! The remainder of the money which finances the athletic program is a result of gate

DEAR EDITOR:

According to Willamette's "Bulletin," the University is devoted to developing "knowledge, Christian character, and a high sense of responsibility." These aims were among the goals that led us, the undersigned of this letter, to enter Willamette where we have lived quietly and well within the rules.

IN TRYING to develop something of the Christian character and high sense of responsibility mentioned above, we became convinced that some of the petty rules which now apply to undergraduates in the Liberal Arts College are hindrances to the development of responsibility and moral self-reliance. Through the years that we have been at Willamette, we have individually taken the responsibility to do what we could to get some of these rules changed.

Recently, the results of these exercises of moral responsibility were well described by a school administrator as follows: "To protest (against any of Willamette's rules) is to create a tempest in a teapot, to have a chip on your shoulder, to show yourself as having the wrong attitude and to butt your head against a stone wall. If you don't like Willamette's rules, you should go somewhere else."

First we wish to stress that we have lived within Willamette's rules and that our actions here are intended only to improve an unfortunate, existing situation. Many students have done precisely what the administrator suggests — they

have found the rules insupportable and have gone elsewhere.

THE LOSS of so many able students among the upperclassmen and particularly among the upper-class women is a serious hindrance to the best use of Willamette's resources and, incidentally, a reduction in potential income as well as a diminishing of upper-class offerings.

The reasons for the heavy losses of women students were well documented and submitted last year in a report to the administration. Unfortunately, the report seems to have been misplaced somewhere.

Since attempts to change the rules have brought at best only token results, we have concluded that the proper approach to the problem is to improve student opinion of the rules. This solution can easily be reached (with student cooperation) by carefully discouraging prospective freshmen who might find Willamette's rules insupportable.

LOOKING AT things in this constructive manner, the problem has become better defined, but still it is not an easy one. How do we recognize these prospective freshmen who might become dissenters? We don't want to discourage everyone, only those who would find the rules insupportable.

Fortunately, as rumor has it, Willamette's administration has made an extensive statistical study to determine the characteristics of the student most apt to dissent. The administration used the results of this study to design its corrective measures ("probation") to be most effective on the most common type of dissenter.

THE corrective measures of probation include the following: "Ineligibility to represent the University in any public appearance or to hold any major office; forfeiture of scholarships or grants; entry made on student's permanent record; . . ." Now what type of student would be a school representative, or a holder of a major office or a recipient of scholarships or grants? Most certainly, the best, brightest and most discriminating students are the representatives, the officers and the scholars. We have now, therefore, clearly deduced from the nature of the dissenter's correction the char-

acteristics of the dissenter.

THE PROBLEM is solved! To rid Willamette of dissension and stop the outflow of upper-class potential, we can either remove the cause of the dissension and outflow or (because removal of the cause is impossible) we can discourage future dissenters from ever entering Willamette.

This, then, is the point at which student support is needed. May Weekend will soon be upon us and many future dissenters will be among the guests. Watch for and discourage prospective students with intelligence and discrimination. They are apt to find the rules here insupportable.

IF YOU SHOULD be in doubt about any guest, have him glance through the "Student Handbook" and that charming book (which should be on reserve in the library), the "Willamette University Dormitory Rule Book: Doney Hall, Lausanne Hall."

These are trying times for all Willamette U. and your support is needed. Write to members of the administration and to the trustees to let them know you are firmly behind them. As a start we suggest that you further document that misplaced report by dropping a note to President Smith, Dean Blake, Dean Ewalt and Charles Paeth. Their addresses are to be found in "The Fusser's Guide."

Students should also use the *Collegian's* DEAR EDITOR column to make known their individual ideas on the supportability of Willamette's rules and to document again the reasons for the loss of upperclassmen. Remember, May Weekend is the time to give your all for Willamette!

Clan Needs 'Get-Together'

There appears on this page this week a letter to the editor which deals with two subjects dear to the heart of the Willamette family—rules and the reasons why students leave Willamette. Current student opinion on the campus indicates that the former equates to the latter. It is this feeling that evidently prompted the signers of the letter to seek an honest meeting of minds to consider both items.

It seems only fair that an honest effort to do something about an irritating situation should be met by those who have the power to make policy, with an equally honest effort to help correct the situation. There are indications that in similar situations in the past, the policy makers have taken an ostrich attitude toward the complaining students. From the administrative side of the fence, many abortive approaches to problems may have been the product of insincerity or inaptitude on the part of the protestors.

Having served in the military, we are familiar with the modes of enforcement encountered from an ultimate authority. These methods are effective, not because they are necessarily just or reasonable, but rather because they leave no choice other than submission. This type of enforcement breeds discontent and sometimes disrespect.

It seems that there is a legitimate comparison to be drawn here. Complete authoritarian rule, without apparent reason or justice, leads to discontent, drop-out and sometimes flagrant violation of rules.

After examining the rule book for girls living in Doney and Lausanne Hall, we found no rules that seemed unfair or unreasonable—rules, that is, of a "formal" nature.

In the book we examined, there were some "marginal" rules hand-written inside the back cover. These rules dealt with the demerit system and room checks. The authorized demerits include penalties for, "1—unmade bed; 2—full wastebasket; 3—dirty floor (dirt and junk) and 4—clothes lying around." These items are followed by the notation, "Demerits listed are approximate; there are no set rules on how many demerits or for what, in room check this year." Even the U.S. Army has a table of maximum punishments.

But this does not solve the problem of getting administration, faculty and students together in a combined effort to honestly appraise and evaluate a situation which is detrimental to the University. The interests of all of those for whom Willamette will some day be "alma mater" are at stake.

Taylor, a student of Professor Stanley Butler, has received several awards and scholarships at Willamette. He has held the Chamberlin-Schultz Scholarship, the Mrs. Walter A. Denton Memorial Award established by the Salem Federated Music Clubs and the Alaskan Music Trails Scholarship. In addition, he tied for first place in a state-wide contest sponsored by the Oregon Music Teachers Association.

Company Sets May Date For Publishing Prof's Book

A new book by Dr. Milton D. Hunnex of Willamette's philosophy department will be published this May. The book, "Philosophies and Philosophers," was four years in the writing and was produced at the request of the Chandler Publishing Company of San Francisco.

The publishers asked Dr. Hunnex to write this book as one that "would serve as a valuable reference manual for those wanting information on philosophy in a hurry—some kind of book that would incorporate some new ideas in reference handbooks," commented Dr. Hunnex.

HE WENT on to say, "It is an inexpensive reference or handbook for the student. It is not a textbook, dictionary or college outline. It is not an extraordinary scholarly masterpiece but is short and convenient."

The book is divided into six parts, including 22 charts to give stu-

dents and readers a visual idea of the historical movement of philosophies and the philosophers who are associated with them.

IN THE BOOK Dr. Hunnex presents views such as realism, idealism, rationalism, empiricism and various theories on knowledge. He discusses theories of the nature of physical and living reality as they have developed.

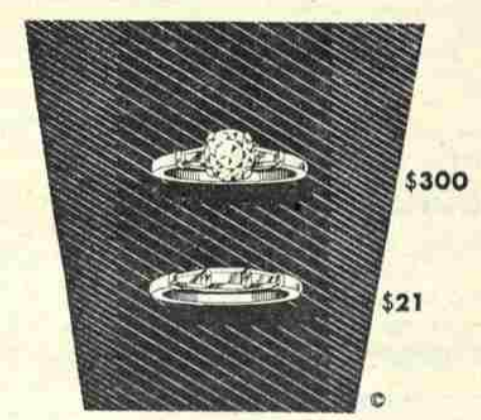
Theories of values, ethics, art and freedom are approached, as well as the philosophy of religion.

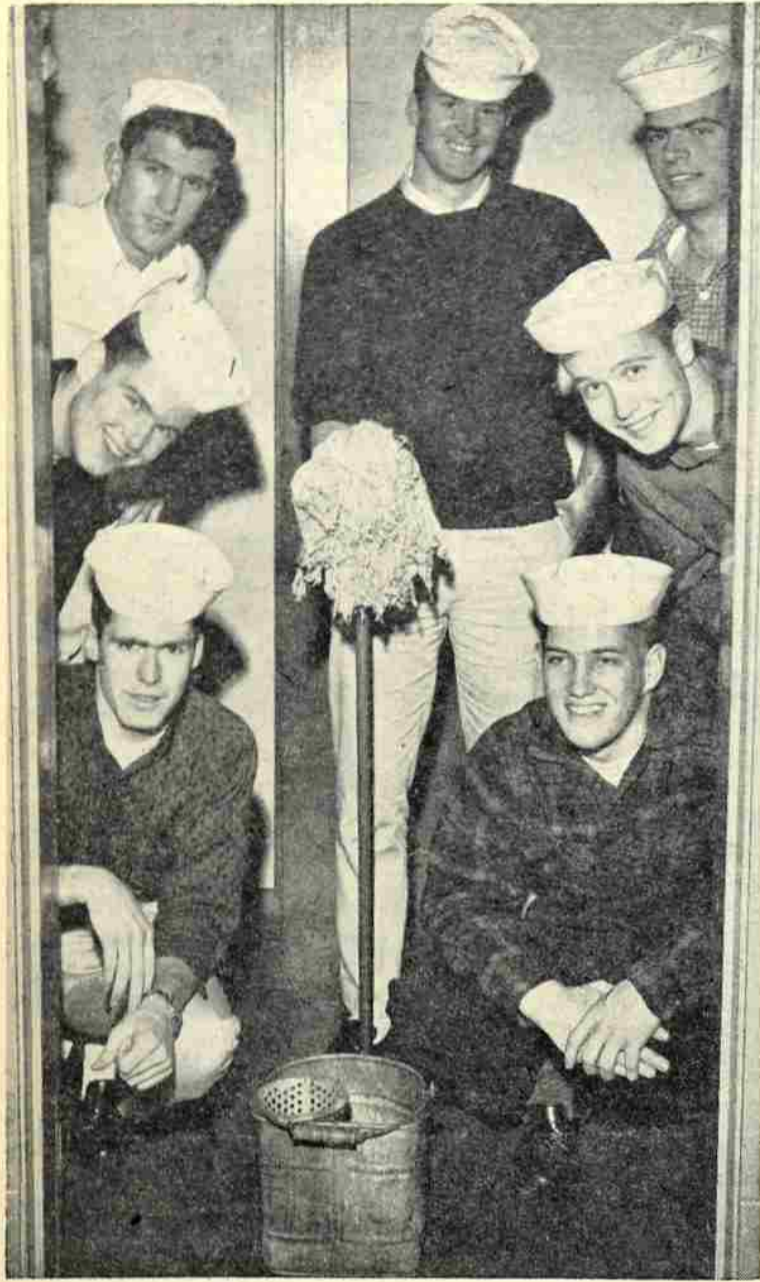

The Law School, fourth with 48 points, was champion in flag football where they tallied 18 points.

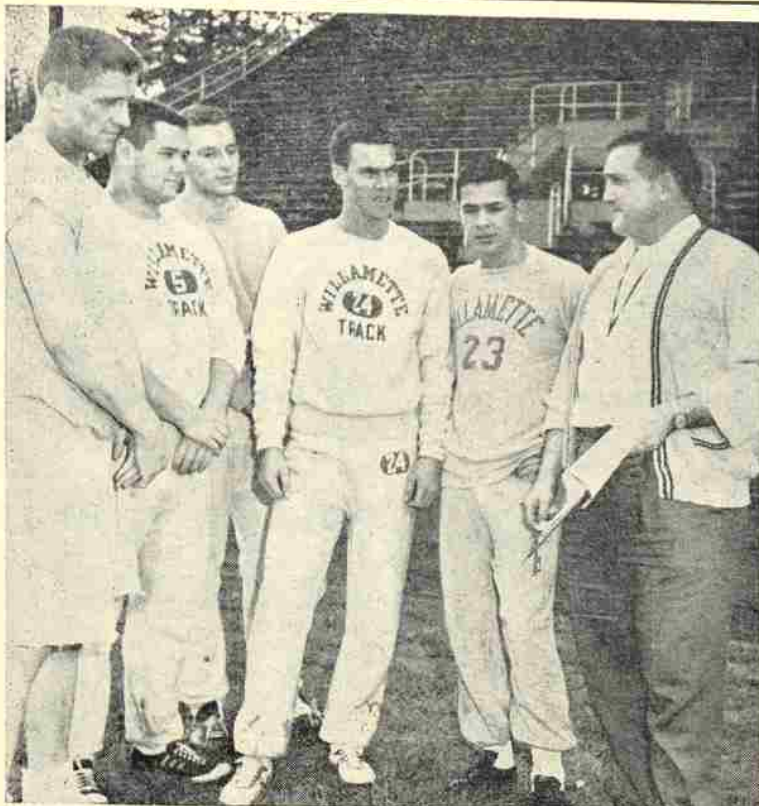
Rinky Dinks Nab Volleyball Wins

"Bravo! Bravo!" cheered the audience as the last curtain, of many curtain calls, fell on the performance of "The Crucible" by Arthur Miller. "The standing ovations and the bravos at the conclusions of both Friday and Saturday night performances are the first to be given any Willamette production," states one "old-timer."

THE PLAYERS, under the direction of Prof. Robert Putnam, captured the spirit of the characters in the drama. Aided by the fine sets and lighting, makeup and costumes, music and sound, the actors were integrated by Putnam into groupings that suggested a series of beautiful paintings by Rembrandt.

John Proctor, portrayed by William Snow, made his entrance on an already dramatic scene. From that moment he commenced to build firmly and convincingly toward the tremendous climax. His faith, not the pretentious but the truly humble and fundamental belief in the need for human integrity, spoke through his actions and words to the audience. Dianne Lord fully captured the simplicity and sensitiveness of the subservient 17-year old Mary Warren. Passionate, devious Abigail Williams, played by Christine Hjelt, led a group of her friends in a courtroom scene of hysteria that brought the audience to the edge of their seats and immobilized them there.

UNDENIABLY Michael Wayland

assumed the character of the twisted yet keen-witted Giles Corey. Anne Peterson, noble as Rebecca Nurse, and Patrick Mitchell as Francis Nurse also played old age very convincingly. Janet Johnson embodied the spirit of the restrained and gentle Puritan as Proctor's wife, Elizabeth, while Theodore Alexander in his role of Deputy-Governor Danforth assumed the proper amount of rigidity and believable self-righteousness. Donald Schlusser remarkably conveyed the transition of the self-assured bright young man, Mr. Hale, into the disheartened, drawn man who even appeared guilty in later scenes at having trusted himself so much in the beginning.

Bush Takes Trophy in Speech Meet

Charles Bush, sophomore, took the first place trophy in interpretive reading at the annual Linfield College Intercollegiate Tournament of Champions, March 2-4. Bush also won second place in oratory. James Monroe, freshman, was also a finalist in the oratory event.

THE MEMBERS of the technical crew deserve congratulations also for carrying out the realistic and attractive set designed by Robert Putnam. Allan Steven's revolving stage made possible the quick changes that kept the mood of the play constant. The make-up by Robert dePew and Langley Brookes was unusually good. Martha Wynd's costumes were excellent in design and color.

The over-all impact of the performance rose out of the very beautiful play staged, directed and played magnificently.

Committee Offers Revisions

Following is the remainder of the proposed revision to the by-laws of the ASWU constitution.

ARTICLE VII. CONVOCATIONS COMMITTEE

Sec. 1. The Convocations Committee shall consist of a chairman, appointed by the Student Senate in the spring semester to serve for the ensuing year, its members appointed by the incoming chairman with the Dean of Students acting as advisor.

Sec. 2. The Convocations Committee shall be responsible for the programs at Tuesday Convocations and shall be empowered to make such rules and regulations governing Convocations as it sees fit. These rules and programs are subject to approval or amendment by the Student Senate.

ARTICLE X. MAY WEEKEND COMMITTEE

Sec. 1. Membership of the May Weekend Committee shall consist of a manager appointed by the Student Senate, the student body treasurer and assistants appointed by the manager. This committee is directly responsible to Student Senate.

ARTICLE VII. HOMECOMING COMMITTEE

Sec. 1. Membership of the Homecoming

Committee shall consist of a manager appointed by the Student Senate, the student body treasurer and assistants appointed by the manager.

Sec. 2. The committee shall promote the Homecoming Sign Contest and other traditions associated with Homecoming and shall be directly responsible to the Student Senate.

ARTICLE XIII. PARENTS' WEEKEND COMMITTEE

Sec. 1. Membership of the Parents' Weekend Committee shall consist of a manager appointed by the Student Senate, the Dean of Students, the student body treasurer and the committee chairmen appointed by the manager.

Sec. 2. The committee shall organize the events of Parents' Weekend and see that they function in proper manner and shall be directly responsible to the Student Senate.

ARTICLE XIV. ORIENTATION WEEK COMMITTEE

Sec. 1. Membership of the Orientation Week Committee shall consist of a manager appointed by the Student Senate, the student body treasurer, the Dean of Students and assistants appointed by the manager.

Sec. 2. The Orientation Week Committee shall have charge of all student activities during the said week except those of Panhellenic and Inter-Fraternity Council. This committee shall be directly responsible to the Student Senate.

ARTICLE XV. STUDENT BODY OFFICE MANAGER

Sec. 1. There shall be a manager of the Student Body Office, hired by the Executive Committee for a period to concur with the term of office of the student body officers. The Executive Committee shall have the power to dismiss this manager at any time if necessary. Likewise, the manager will have the power to employ and release student body office workers who shall apply for employment by petition to the student body office manager.

ARTICLE XVI. RALLY COMMISSION

Sec. 1. Membership of the Rally Commission shall consist of the first vice-president of the student body, who shall act as chairman, the yell queen, the yell king, the general manager, the director of athletics, the band director, a representative from the Alumni and Information Office and the immediate past year's yell queen and yell king. If either or both of the immediate past yell queen and yell king cannot serve, the student body president shall fill each vacancy from the rally squad of the past year if possible.

Sec. 2. The purpose of the Rally Commission shall be to organize all phases of school spirit and interest in connection with athletic contests held throughout the year. The Rally Commission shall devote particular attention to co-ordination of the functions of the rally squad, the band, the Athletic Department and any organizations concerned with school spirit. It shall also co-ordinate and develop publicity and promotion of the school's athletic events. The Rally Commission shall hold preliminary tryouts at which time candidates for the rally squad will appear individually. It shall

choose not more than twelve women and nine men to appear on the election ballot. The Commission will decide the size and composition of the groups appearing before the student body for demonstration of ability. It shall appoint other members to the rally squad subject to provisions of Sec. 3 of this Article.

Sec. 3. Membership of the rally squad shall consist of five women and three men serving as a yell squad, to be selected in the spring semester of each year serving for the next school year. The Student Association will vote on the candidates as individuals, voting for as many candidates as there are positions to be filled. The five women and three men receiving the highest number of votes will comprise the rally squad. The two women and the two men receiving the highest number of votes will then be voted upon in a new election. The woman and man winning a majority shall become yell queen and yell king respectively. In the event of a vacancy occurring in the rally squad, that candidate with the next highest number of votes will fill the vacancy.

Sec. 4. The duties of the rally squad shall be to provide leadership for the student body at athletic contests and related activities. The primary duties of the rally squad shall be to lead yells.

ARTICLE XVIII. RULES OF ORDER

Sec. 1. Roberts Rules of Order Revised shall govern Senate and Association meetings except as otherwise provided by the Constitution or By-Laws.

Internships Accepted by Savage, Green

Jean Savage and Lyle Green, WU juniors, are presently serving as interns in the Oregon Legislature. Miss Savage is intern to Senator Jean Lewis, Democrat, from Portland. Green is intern to Representative Doug Heider, Republican, from Salem.

Both students have been attending legislative sessions and working on research for their respective legislators. Miss Savage has worked on several education reports and Green on a variety of issues.

The internship program is conducted by the non-partisan Citizenship Clearing House, "a national educational organization established to stimulate the development of political leadership." Founded in 1947, the CCH seeks to thoroughly involve interested students in politics through service for political parties, government officials and interest groups.

The two interns from Willamette were selected by Willamette's political science department on the basis of pre-requisite courses they have taken, scholarship and political activity. For the 100 hours they must put in, each will receive a \$100 "honorarium."
