

Long Time W. U. Professor Dies



DR. ROBERT GATKE, as he appeared standing before the building that now bears his name, died last Thursday after suffering a cardiac arrest and pneumonia.

Dr. Robert Moulton Gatke, Professor Emeritus and historian of Willamette University, died last Thursday night in a Salem hospital. Dr. Gatke succumbed to a cardiac arrest and pneumonia; he was 72 years old.

Born in Ludington, Michigan, on January 31, 1896, Dr. Gatke began his association with Willamette University, which was to span some 54 years, as a student in the fall of 1914. It is said that he registered after some difficulty, due to a rather casual combination of high school courses. Once in, according to a story previously printed in the Willamette Alumnus, he again set out happily on a wide sampling of the curriculum. The effect of this was brought back to him not so long ago while researching old University records. In the faculty minutes he found this: "Professor Matthews moved that Mr. Gatke take plane geometry whether he takes anything else or not."

Originally intending to become a minister, Dr. Gatke received a B.D. degree from Kimball College of Theology. During this time he also taught several courses in history and apparently enjoyed the experience because for the rest of his life, he made teaching his main occupation. He then received his Ph.D. in history from American University in Washington, D.C. and in 1919 he joined the Willamette faculty as a professor of history. Not long after, as a response to the demand of some of his

students, Dr. Gatke, apparently without any formal sanction from the faculty or administration, offered the first political science course to be taught at Willamette. This marked the formal beginning of the Political Science Department at W. U. Dr. Gatke's list of students who rose to prominence in the political arena is long and impressive. They include Senator Mark Hatfield, Senator-elect Robert Packwood, Ivan White, Chief of the European Desk in the State Department, and many noted judges, legislators, lawyers, and educators.

Besides his teaching activities, Dr. Gatke was the author of the book "Chronicles of Willamette." Begun in 1919 as a Master's Thesis, the first volume, published in 1943, emerged as a seven-hundred-page volume dealing with the history of this University.

Dr. Gatke retired in 1961 and continued his work on the second volume of his book until his death. During his tenure at Willamette, Dr. Gatke was honored with three academic degrees, and last year the University awarded him an Honorary Doctor of Humane Letters degree. Further, just this last spring the Board of Trustees paid tribute to him

for his long and productive years of service by naming the former Law School building Gatke Hall. Appropriately this building now houses the Political Science and Economics departments.

In addition to his scholastic activities Dr. Gatke was an accomplished horriiculturist. Much of the present landscaping of this campus is Gatke's work. The circle of huge sequoias near Collins Hall was planted by him as tiny saplings. This work continued through the depression years when budgets were lean --- to put it generously. (Gatke spoke respectfully of the opportune bankruptcy of a nearby nursery.)

A public memorial service was held for Dr. Gatke Monday following a private family service. Survivors include his wife, Estelle, two sons, Robert M. Gatke, Jr., and Richard B. Gatke of Hillsboro, and eight grandchildren. Dr. Gatke will not be forgotten at this school, to which he gave so much of his time and energy. His memory shall remain in those students whom he taught and the school he helped to build. In tribute to his memory, we of the Collegian would like to dedicate this issue to him.

Students Save At Bookstore

The Willamette University bookstore has long been a source of mystery to many students, especially when that time comes to pay for a semester's supply of books. In an effort to discover the true facts concerning the operating policies of the bookstore, the Collegian interviewed Mrs. G. H. Sanders, bookstore manager, Mr. David Lewis, W. U. business manager, and Dr. Richard Petrie, Financial Vice President. In essence, all three insisted that the bookstore, within the limits of its capacity in terms of space, is providing the best possible service to the Willamette student.

When questioned as to whether or not the bookstore is designed to make a profit in the form of higher prices on books, Mr. Lewis stated that "No money is made on books, especially on hard copies." He pointed out that all prices are set by the publishers and that from his investigation prices at Willamette compare favorably with Oregon State University and Reed.

Dr. Petrie stated that the bookstore as it is now set up is not geared to excessive profits. He pointed out that since the bookstore is a part of the university, it does not have to pay for rent, lights, or heating. All of these costs are simply absorbed by the University. He contended that when these factors are added to the cost of the bookstore, the student is in fact receiving a benefit by having the bookstore run as a University endeavor.

Mrs. Sanders pointed out that there are three full-time employees and six part-time student employees who work a total of between five to ten hours per week on the staff.

When questioned as to the possibility of establishing a cooperative bookstore, all three individuals replied that they were not in the least opposed to such an action, but questioned

whether one could be financially successful. Dr. Petrie pointed out that the bookstore at present has an inventory of over \$40,000 at its lowest point on May 31 of each year and that consequently, the University loses the interest on at least this amount of money. Mr. Lewis pointed out that a cooperative, by the fact that it would have to be run as a business, would have to pay for rent, lights, and maintenance, which are not now included in the cost of the bookstore.

Finally, all three expressed anticipation towards the proposed new bookstore which will be part of the new Student Center. It will be some 6,000 square feet, twice as big as the present bookstore, and fully air conditioned. Mrs. Sanders stated that with the increase in size, a greater variety of books and other items will be offered; and Mr. Lewis stated that a used book section would be opened. In conclusion, Mr. Lewis emphasized that it is the responsibility of the students, and the faculty as well, to let the administration know what they want and expect in a bookstore. Every endeavor will be made, he stated, to consider and incorporate all constructive suggestions.

Financial Aid Forms Available

The 1969 - 70 application forms for financial assistance are now available in the Financial Aid Office, Room 4, Eaton Hall.

To be considered for any financial assistance, including a loan, a student is required to have a current Willamette University application and a 1969-70 Parents' Confidential Statement on file.

To be assured notification of financial assistance before the end of the spring semester 1969, a student must make application before February 15, 1969.

Urban Renewal Director After Willamette Land

"A tempest in a teapot" describes the situation concerning Willamette University and Salem Urban Renewal Agency according to University vice-president Richard Petrie. The possibility of Willamette's losing six parcels of land acquired through the urban renewal program was brought to public attention at Monday evening's City Council meeting.

James Tooze, Executive Director Salem Urban Renewal Agency, explained to the City Council that Willamette University had failed to comply fully with its agreement regarding the land. The six parcels of land were to be developed or development begun within six months of acquisition by the Urban Renewal Agency or face selling for alternative use.

The parcels of land in question are found adjacent to 12th Street, south of Mill Street and one parcel south of sorority row. Petrie noted that the University had fulfilled its plans for developing the large parcel of land behind most of the sororities and will eventually use it as an intramural athletic field.

Meetings Scheduled

According to Petrie the land next to 12th Street will not be developed until funds are available --- plans have been approved by the Urban Renewal agency for its development, with no specific completion date set. Making an effort to insure

continued availability of the land, meetings between the University administration and city officials have been planned.

Noting that violation of the agreement with regard to developing the land in six months is "only one point in a 14-page document" Vice-President Petrie sounded confident that Willamette will retain full use

Spring Weekend, Convo Heads Picked By Senate

The only order of business discussed at this week's Senate meeting was the selection of Spring Weekend Manager and Convocation Manager.

Joe Trachtenberg, a Junior from Belknap, was chosen as next year's convocations manager. He feels that there is no justifiable reason that Willamette cannot be kept aware of, and better informed on the wide range of happenings going on outside of Salem and off our campus. Trachtenberg told the Senate, "Hubert Humphrey and Arthur J. Goldberg, just to name two, ARE available as speakers and there is no reason why we should consider Willamette University's Convocations Committee as being presumptuous and unrealistic in considering such men as possible guest speakers.

He suggested to ask the people of Salem to contribute donations

of the area. Technically the urban renewal agency is supposed to reclaim the property and sell it for alternative uses if not utilized within the allotted time.

Several businesses, including a hotel and tavern were once located on the 12th Street lots now the future site of Willamette University field house and swimming pool.

for the procuring of Convocation speakers, as they would probably be just as interested in the convocations as the students would be.

Trachtenberg is president of this year's defunct Model United Nations. Through this organization, he stated that he could get U.N. delegates, ambassadors, etc., to come to Willamette to speak.

Betty Wellenbrock, a Sophomore from York House, was chosen as this year's Spring Weekend Manager. Her main proposal was to concentrate on the academic points of Willamette, rather than highlighting the social aspects. Betty commented that she would like to highlight the crowning of the Spring Weekend queen, have the seniors meet in an informal situation with professors and students representing specific majors, and revive an all school picnic.

S. Claus Reported Dead

(NORTH POLE) --- At a special news conference this morning, Rudolf, Press Secretary and member of the flying team, announced that his long time friend and traveling companion, SANTA CLAUS, was officially listed as missing and presumed dead.

Santa, who disappeared 12 days ago on a flight from his summer home in South America to his winter workshop in the Arctic, has been the object of an intensive air and sea search. He was last heard from on December 2, 1968. At that time, Santa reported his position as 150 miles SW of Iceland. Weather conditions in the area have hampered search efforts since that time.

News of this tragedy came as no surprise to waiting newsmen, who, for several days, had observed an unusually large number of Reindeer flights to and from the vast tundra regions of the Arctic.

As reports of Santa's "death" flashed throughout the world, reaction was mixed. In Moscow, Premier Kosygin stated that "his death was most likely connected with a C.I.A. plot to abolish Arctic travel, thus allowing the United States full access to the area for purposes of aggression."

The reaction in other Communist countries was similar. A spokesman for China's Mao Tse-tung lashed out at the United States for what he called "imperialist attempts to undermine the spirit of the young." While addressing the 28th annual Peoples Congress, Mao accused both the U.S. and the Soviet Union of conspiring to weaken relations with China. "After all," he stated, "is it not true that the Chinese people were the first to recognize Comrade Claus as their chief minister of goodwill?"

Radio Hanoi reacted immediately to Santa's disappearance. The North Vietnamese claimed to have shot down an unidentified sleigh and nine tiny Reindeer over the outskirts of Hanoi on December 2nd. The U.S. Defense Department has denied all knowledge of the incident.

Telegrams and letters of sympathy streamed in not only from the East, but also from the free - world countries. In Rome, Pope Paul VI addressed a large crowd which had gathered for prayer in St. Peter's Square and said "St. Nicholas" (known as Santa Claus in the non - Catholic world) "was a fine gentleman. We all knew him well. His was the spirit of light and hope. His death is our loss. It will always be remembered how he supported the Vatican's views on The Virgin Birth, The

Trinity and Birth Control."

In this country President Johnson ordered all flags to be flown at half staff and appointed a special Congressional investigatin committee to look into the mysterious circumstances surrounding the disappearance of Santa Claus. It was hinted in Washington that Chief Justice Earl Warren would be appointed to head the special fact - finding committee appointed by the President.

Elsewhere in Washington, President - elect Richard M. Nixon declined comment while Vice President - elect Spiro T. Agnew remarked, "SANTA WHO?"

Former President Harry S. Truman, commenting from his

home in Missouri, stated, "It's a shame!"

Santa's disappearance was reflected on the New York stock market where trading was brisk. The closing stock index was down 3.79.

A spokesman for the New York Retail Merchants Association disclosed that his association would not bend to the wishes of the public and remove "Santas" from their stores. He claimed that such an action would decrease Christmas sales by 15%, "a figure totally unacceptable to the Association."

As of late this afternoon, there is still no word as to the fate of SANTA CLAUS. A watchful world waits and hopes!

Law Corner

In meeting some of the problems encountered most commonly among the poor, some of which were outlined in last week's column, the law student has found a willing ally in the Marion County Bar which is anxious for his help and gives valuable practical experience as a form of compensation, not to mention fulfillment of the professional concept of the attorney's service to the community through its Legal Aid Clinic.

Through the clinic, there is a joint control over the mechanics of legal aid. The student acquires the necessary facts from the applicants who have qualified for legal aid and is able to pin down the area of law into which the case falls and make a threshold judgment as to the merits of the case and the action to be taken. He then will consult with either of the two full - time staff consultants, Mr. M. J. Willson or Mr. Ted King (a 1967 graduate of the College of Law) and action will follow. Federal funds have allowed expansion so the clinic is also able to employ two secretaries, a receptionist and an investigator.

Though often used for the aid of Black and Mexican minorities, the clinic is also often used by poor whites who are more common in the locale. Expansion to aid more of the county and surrounding area is hoped for, though a clinic in Woodburn for legal aid to Russian families on a weekly basis is limited due to lack of resources.

Should the applicant have an

income in excess of the OEO requirements, the Clinic has a Lawyer Referral Service. The interviewing student will describe the service and ask the applicant if he desires to make use of it. If so, the next attorney in a rotating card file is picked and called, and an appointment made if desired. It is believed that many applicants actually confer with the attorney who is generally more lenient with charges.

According to Grant Nelson, student coordinator of the clinic, the law student's participation in clinic activity has been weaker than that of the Marion County Bar. Outside of a hard-core group of approximately 18 of his number the Willamette Law Student has been less idealistic than those within his chosen profession or students generally. To Mr. Nelson, this lethargy is incomprehensible in view of the vast potential gains in terms of familiarity with the problems attorneys often encounter and legal experience for future practice. Yet the groundwork has been laid and it is hoped the vessel will soon right itself.



Bearcats Beaten

If performance is any indication, there may be some wholesale lineup changes due the Willamette Bearcat basketball squad, and head Coach Jim Boutin only adds fuel to this statement after last week's disastrous --- and disappointing --- performance in the annual N. A. I. A. Tip - Off Tournament held partially in Willamette's gym.

Which is just a long way of saying that one narrow loss, one narrow win, and one disastrous loss is no way to start out a maple court season. The squad of veteran Bearcats had their moments in last week's tourney, but they were too few and too far between to make any significant changes in the outcome of the three ball games. And fifth place is the worst showing by a Bearcat team in the 10 years that the tournament has been held.

The first game --- with Oregon Technical Institute's Owls --- was by far the Bearcats' best game of the four-day clambake, and the following summary might show people that it was not even as good as it sounds. All-tournament guard Harvey Sebree and his jumping jack playmate, center Larry Griffin, also all-tournament, dominated the scoring and rebounding, respectively, as the Owls came perilously close to accomplishing a very minor upset over the experienced Bearcats. Sebree scored 42 points, just four short of the tournament record of 46 by Ashley Court of E. O. C. --- and Griffin, before he ran into foul trouble in the second half, lead all rebounders. On the other hand, Willamette's team was having their ups and downs. They would get extremely hot for a time, with Bob Lundahl hitting 20- and 25-footers over the Owl zone, and the hooks of John Barker inside, then all of a sudden collapse and let Sebree and his playmates play catch-up.


This back and forth kind of game lasted until the final 10 seconds, when, with the score tied 95-all, Lundahl's 25-foot swisher from the right sideline put the game on ice. The Owls had one more shot inside before the whistle, but it bounced off the rim.

In the second game, these same hot - and - cold tactics proved their dismantling. Doing the dismantling was Boutin's old alma mater, Lewis and Clark, who hit on 15 of their

first 19 shots and never looked back in their 102-78 massacre. The Pioneers eventually went on to defeat Warner - Pacific in the title game. The Bearcats had their rallies in this game also, unfortunately, Lewis and Clark did also, but there was one slight difference: the Pioneers' rallies were longer and their shooting during them much more accurate. Lundahl led the 'Cats with 18 points after a 25 - point production the night before against O.T.I.

The final game for third and fifth places was another cliff-hanger --- at the finish. During the actual ball game, Pacific University was clearly in control and only at the end did they lose momentum. The final score was 78 - 76 with the Badgers surviving a last-ditch rally by the 'Cats in the final minutes of play. Bob Lundahl once again led the Willamette team with 17 points.

As this is the last issue of the COLLEGIAN before finals and Christmas vacation, all of the intermediate games will be covered in the first issue of the COLLEGIAN next semester. Those games include Cascade College, So. Oregon College, The Chico Christmas Tournament, and two games with the Pacific Lutheran University Black Knights, in Tacoma, Washington.


The final tally was a satisfying 21-16.
